**Barbara Murphy Leary, Indian Walk Road,** questioned why there are only two small job descriptions for the Assistant Administrator. It was stated that the Ordinance follows state statute and that normally job descriptions are not included in an Ordinance creating a position. The Assistant Administrator will take direction from the Administrator on day to day duties as well as fulfill the duties of the Administrator in the event of his or her absence. She later inquired if all open positions with the Township are required to be posted to the public. It was stated that it is a Township policy that open positions are posted, but it is not required statutorily.

Blanch Adams, Woodbine Road, stated that the Upper Township Business Association will be happy to assist with gathering qualified candidates for an Assistant Administrator position.

**Bonnie Collins, Upper Township,** stated that the Ordinance is vague and questioned the need for an additional administrative position.

**Don Oral, Palermo,** stated that he has always been impressed with how the Township was managed, and questioned why an additional administrator is needed. He proposed that if an Administrator and Assistant Administrator are hired, then the Township Committee should become a voluntary body.

There being no further speakers Deputy Mayor Newman closed the public hearing. Motion by John Coggins to table Ordinance 002-2022 until the Mayor is present for the vote. The motion was not

seconded. Motion by Kimberly Hayes, second by Mark Pancoast, to adopt Ordinance 002-2022. During roll call vote three Committee members voted in the affirmative. Committeeman Coggins voted no.

WHEREAS, pursuant to N.J.S.A. 40A:63–7.1 the governing body of any municipality, by ordinance, may create the office of Assistant Township Administrator to assist in the administration of the township under the direction of the Township Administrator; and

WHEREAS, the Township Committee of the Township of Upper has determined to create the

position of Assistant Township Administrator pursuant to the provisions of N.J.S.A. 40A:63-7.1.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee, in the Township of

Upper, County of Cape May and State of New Jersey, as follows:

SECTION 1. Chapter II of the Revised General Ordinances of the Township of Upper, also

known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

#### **Revise and replace the following in Section 2-2.4:**

2-2.4 Township Administrator.

- a. Unchanged
- b. Unchanged
- c. Unchanged
- d. Unchanged
- e. Powers and duties. The Township Administrator, under the supervision and control of the Township Committee, and to the extent not prohibited by law, shall:
  - 1. Be the chief executive and administrative official of the Township of Upper with respect

to all of the executive responsibilities of the Township. The Township Administrator shall perform such duties in each department of the Township under the general supervision of the member of the Township Committee appointed by the Township Committee as the head of such department.

- 2. Act as liaison between the Township Committee, the Township Committee department heads, all committees, officers and employees.
- 3. Be responsible for the maintenance of sound personnel policies and administrative practice and to study and make recommendations in respect to personnel, hiring, organization and policies of the Township after consultation with the Township Committee and the department head of each department.
- 4. Assist in the preparation of the budget and assist the Township Committee in obtaining the necessary data for the preparation of the municipal budget.
- 5. Investigate all complaints regarding Township services and, after consultation with the department head of the services involved, to answer same and report the disposition thereof to the Township Committee.
- 6. Coordinate for the Township Committee the general affairs of the Township, including recommendations with respect to purchasing, administration and enforcement of contracts, leases and franchises.
- 7. Attend all meetings as directed and authorized by the Township Committee.
- 8. Perform such other duties as may from time to time be specifically assigned to the Township Administrator by the Township Committee.
- f. Unchanged

# Add Section 2-2.10 Assistant Township Administrator

- 2-2.10 Assistant Township Administrator.
- a. Creation of Position. The office of Assistant Township Administrator is hereby created in and for the Township of Upper pursuant to the provisions of N.J.S.A. 40A:63–7.1.
- b. Appointment and Term. The Assistant Township Administrator shall be appointed by the majority vote of the Township Committee and the term of office of the Assistant Township Administrator shall be at the pleasure of the Township Committee.
- c. Compensation. Compensation to perform the duties and responsibilities of Assistant Township Administrator shall be determined and established by the Township Committee in accordance with law.
- d. Qualifications. The Assistant Township Administrator shall possess knowledge and experience in local government.
- e. Powers and Duties. The Assistant Township Administrator, under the supervision and direction of the Township Administrator, shall assist the Township Administrator in the administration of the Township. During the absence or disability of the Township Administrator, the Assistant Administrator shall have all

the powers and duties of the Township Administrator and shall perform all of the functions of the Township Administrator.

SECTION 2: EFFECTIVE DATE: This ordinance shall take effect immediately upon

<u>SECTION 1</u>: Sections 4 and 9 of Ordinance No. 017-2021 are hereby amended and replaced in their entirety with the following:

SECTION 4: Benvenuti shall pay \$1,500.00 to the Township Clerk prior to the sale of Block 10, Lots 124 and 125. \$500.00 of this payment will be used by the Township to defray Township expenses involved in Authorizing the Sale and terms thereof; Engineer's review; Attorney's review; legal advertising, certified mail notices, closing costs and other expenses. \$1,000.00 of this payment will be used to cover title search costs, which if same are less than this sum the difference will be credited back to the ultimate payor. If the parcel is not sold, \$500.00 of this amount will be retained by the Township as **LIQUIDATED DAMAGES** and will be used to pay for the review of the title report and other documents. If the highest bidder at the auction sale is <u>not</u> the original applicant, the highest bidder will be required to pay, in addition to the purchase price and other expenses, an additional sum of \$1,500.00, representing pre-sale amounts paid by the original applicant requesting the sale and the original applicant (who is not the highest bidder) will then be entitled to a refund of all sums paid (\$1,500.00) except for the non-refundable application fee (\$50.00).

SECTION 9: A sum equal to ten percent (10%) of the highest bid for said parcel or parcels shall be paid to the Township of Upper by the highest bidder or bidders at the time of the sale. The remaining balance of ninety percent (90%) of the highest bid for the parcel or parcels shall be paid to the Township of Upper, and must be received by the Township Clerk, not later than thirty (30) days after the date of the sale. In addition to the deposit of ten percent (10%), the highest bidder or bidders shall also be required to pay or tender at the time of sale the following:

- (A) (i) The sum of \$100.00 for the preparation of the Deed; and
- (ii) the sum of \$70.00 for recording the Deed.

#### **IF THE BIDDER IS NOT THE ORIGINAL APPLICANT:**

(B) The sum of \$1,500.00, payable to the Township of Upper, representing payment to the Township for expenses of \$1,500.00 to defray Township expenses, which amounts were required of the original applicant.

- (C) (i) The sum of \$100.00 for the preparation of the Deed.
- (ii) The sum of \$70.00 for recording the Deed.

(D) Any additional sum required for title search or title insurance.
