ORDINANCE NO. 007-2022

**RE: AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE
CHAPTERS 7 AND 7A OF THE CODE OF UPPER TOWNSHIP**

BE IT ORDAINED by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

SECTION 1. Chapter 7 of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereafter provided:

Replace **Section 7-3.4** in its entirety with the following:

7-3.4 Parking Prohibited During Certain Hours on Certain Streets.

No person shall park a vehicle between the hours specified in SCHEDULE II on any day upon any of the streets or parts of streets described in SCHEDULE II included in Chapter 7A.

SECTION 2. Chapter 7A of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

Add or amend the following to **Chapter 7A Traffic Schedules.**

SCHEDULE I – NO PARKING

Street	Location
Cove Rd	Both Sides for its entire length

**SCHEDULE I(a) – PARKING BY PERMIT ONLY IN DESIGNATED
RESIDENTIAL AREAS**

Street	Location
DELTE ALL STREETS LISTED.	

SCHEDULE II – PARKING PROHIBITED CERTAIN HOURS

Street	Side	Time limit; Days	Location
Neptune Ave*	Easterly Side	9AM – 12PM May 1 to September 30	beginning at a point 25 feet from the northeasterly corner of Williams Ave and Neptune Drive and extending to a point 50 feet south of the intersection with Winthrop Avenue.

*Parking prohibition does not apply to Township vehicles or to Township on duty employee vehicles with a Township permit.

SECTION 3: REPEALER: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

SECTION 4: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

SECTION 5: EFFECTIVE DATE: This Ordinance shall take effect upon final adoption and publication as required by law.

SECTION 6: CODIFICATION: This Ordinance shall be codified in the Upper Township Code at the sections referred to above.
