Motion by Jay Newman, second by Kimberly Hayes, to approve the May 9, 2022 Regular and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Mark Pancoast, Committeeman, reported on a recent phone call from a resident regarding a clogged drainpipe at Marshall Pond and the successful mitigation of the potential hazard. He next reported that Gypsy moth spraying is underway. Lastly, he reported that he recently attended several sporting events at Amanda's Field over the weekend and stated that he received numerous compliments on the immaculate grounds.

Kim Hayes, Committeewoman, thanked Blanche Adams and Steve Zellers from the Upper Township Business Association for meeting with her and the Township Administrator. She next gave a brief update on the plans to install a disc golf course at Amanda's Field. She next reported that she recently attended a meeting last week with the NJDEP Commissioner. She stated that the meeting was very informative and was well received. Lastly, she acknowledged the passing of a prominent member of the community, Dr. Thomas Henry.

Jay Newman, Committeeman, reported on the efforts he and Committeeman Pancoast have been working on to alleviate some of the traffic issues on the Township streets in the vicinity of Roosevelt Blvd. and stated that traffic humps will soon be installed on Randolph Blvd. to hopefully alleviate the speeding issues. He next thanked the Upper Township Business Association for the wonderful Community Guide that was published in conjunction with the Ocean City Sentinel and thanked them for the nice article about the Marmora Fire Company's 75th anniversary.

Curtis Corson, Mayor, reported that parking enforcement is scheduled to begin this weekend in Strathmere, and they will also be monitoring the fire lanes at the ShopRite and Acme shopping centers. He next reported that a Memorial Day ceremony will be held at Osprey Point on May 30th at 11:00 am. Lastly, he reported that the Historical Preservation Society will be holding their annual Strawberry Festival on Saturday May 28th at the Gandy Farmstead.

1. Municipal Court

Paul Dietrich, Municipal Engineer, reported that nesting piping plovers are back on the beach, and reminded everyone that fireworks and dogs are not allowed on the beach. He next reported that an EDF intern from Sustainable Jersey has been assigned to the Township to analyze building emissions, and the Township's vehicle and energy usage. Last, he requested approval to attend the New Jersey Floodplain Association conference at a cost of \$360.00. Motion by John Coggins, second by Kimberly Hayes, to approve the request. During roll call vote all five Committee members voted in the affirmative. Committeeman Coggins requested an update on the beach erosion from the recent storm. Mr. Dietrich stated that there was some scarping on the secondary dunes and estimated that about 50,000 cubic yards of sand was lost.

- 5. CONTRACT TERM. The term of this Agreement is for the period of one year from date of full execution.
- 6. SEVERABILITY. If any section, subsection, paragraph, sentence or other part of this Resolution is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee in the Township of Upper, County of Cape May and State of New Jersey as follows:

SECTION 1: The Township of Upper is hereby authorized to sell to the NJDEP the real property commonly known as follows:

Block 479, Lots 70 and 72

in accordance with N.J.S.A. 40A:12-13(b)(1). Pursuant to said statute such sale shall not be for less than the fair market value of said real property and the fair market value of said parcels sold as well as the purchase price of same is hereby established as follows:

Block 479, Lots 70 and 72

Fair Market Value: \$82,500.00

SECTION 2: Prior to said sale, either the Township or the NJDEP will obtain a title report from a title company or abstract company licensed to do business in the State of New Jersey.

SECTION 3: The list of property authorized to be sold together with the sale price shall be posted at Township Hall and advertisement of the sale shall be made in a newspaper circulating in the Township within 5 days following enactment of this Ordinance. Offers for the property may thereafter be made to the Township Committee for 20 days following said advertisement. The Township Committee may reconsider this Ordinance not later than 30 days after enactment and thereafter advertise the property for public sale pursuant to N.J.S.A. 40A:12-13(a). The Township Clerk shall file with the Director of the Division of Local Government Services in the Department of Community Affairs sworn affidavits verifying the publication of the foregoing advertisements.

SECTION 4: In the event the Township Committee receives no offers for the property pursuant to the advertisement of same in accordance with N.J.S.A. 40A:12-13(b), the NJDEP shall purchase same in accordance with this Ordinance. The Township Committee expressly reserves the right to revoke its authorization to sell the subject real property any time prior to consummation said sale. The Township Committee is authorized to confirm the sale by resolution to complete the transaction pursuant to this Ordinance and N.J.S.A. 40A:12-13.

SECTION 5: At the time of closing, the NJDEP shall be required to pay the following sums in addition to the purchase price:

- (A) Any sums required for title insurance.
- (B) The cost of any survey ordered by the purchaser.
- (C) Title company settlement fees covering services to the purchaser.

SECTION 6: The Deed from the Township of Upper shall be what is commonly known as a Bargain and Sale Deed.

SECTION 7: The title to be delivered by the Township shall be free and clear of all taxes up to and including the date when the Deed is delivered and closing takes place. Purchaser shall be responsible for all taxes thereafter. Unless otherwise specified herein, the purchaser shall be liable for payment of all assessments, of any nature, against said land.

27. **Regulation of seasonal units.** The Township Administrator reported that in response to recent complaints regarding nuisance behavior at an Air B&B rental property, the current code was researched, and it has been determined that the current code will be able to handle the resident complaints with increased enforcement of the laws already on the books.

NEW BUSINESS

- 28. Bruckner Chase Ocean Positive Inc. proposed grant for improvements to Beesley's Point Park. Committeewoman Hayes reported that Ocean Positive has received a grant from the Christopher and Dana Reeve foundation and would like to donate a changing station for the paraathletes. The design satisfies all ADA requirements and is acceptable to County Open Space. She stated that with using the grant funds and DPW labor, an additional \$3,000.00 is still needed. After a brief discussion, it was decided that Committeewoman Hayes would work with the CFO to find the funding for the project.
- 29. **Amendment to Facility Use Ordinance.** Committeewoman Hayes stated that two businesses have approached the Township to utilize the Strathmere beach and Beesley's Point Park for yoga, however the fees are prohibitive. She proposed changing the fee ordinance to offer a onetime seasonal fee for community health initiative type programs. After a lengthy discussion, the Township Administrator was directed to work with Committeewoman Hayes to put together a proposed change to the facility use fee structure and bring it back to the Committee for further review.
- 30. **UT/OC Municipal Alliance DMHAS Grant.** Motion by Jay Newman, second by Kimberly Hayes, to move forward with the Grant application. During roll call vote all five Committee members voted in the affirmative. A resolution for formal action will be placed on the next agenda.

Blanche Adams, Upper Township Business Association, thanked Committeewoman Hayes and Administrator DeMarzo for recently meeting with her and Steve Zellers and stated that she appreciates the open communication and continued support of Upper Township businesses.

Kaitlynn Quirk, Marmora, inquired into the plans, if any, for the corner lot of Roosevelt Blvd and Route 9, and stated she and her fiancée would strongly support the Township purchasing the lot and turning the lot into a park. It was stated that at one time the lot was offered to the Township however because of remediation issues and costs, the Township did not accept the property. The property owners have now put the lot on the market for sale.

Barbara Leary, Seaville, read a statement into the record regarding the Township Administrator position and the Township's appointment of Mr. DeMarzo. She stated that she has filed a complaint with the Cape May County prosecutor's office regarding the Township's hiring practices and urged all residents to do the same.

James Burger, Petersburg, stated that the events held on Saturday at Amanda's Field were a huge success and thanked the Public Works Department for the beautiful facility.

Janice Connell, President Strathmere Improvement Association, reported that last Tuesday the SIA unveiled two interpretive signs at the entrance to the Corson's Inlet State Park describing Strathmere's role in the Atlantic flyway for migratory birds and the twelve endangered species found in Strathmere's natural area. She also spoke about nuisance complaints regarding excessive noise, underage drinking, and dogs on the beach.

Nathalie Neiss, Petersburg, spoke about numerous items including the public safety director, the five-minute limitation on public comment, and Airbnb. Ms. Neiss then submitted a letter regarding these items to the Committee.
