Resolution 22 - 02

Authorizing Appointment/Selection of Accountant, Legal Solicitor, Publication Papers, Banks and Meeting Dates/Time for 2022.

---

WHEREAS, there exists a continuing need for certain professional services and operational decisions necessary for Commissioners of Fire District # 3 in the Township of Upper, County of Cape May concerning various responsibilities undertaken by said Commissioners; and,

WHEREAS, the Commissioners are desirous of making such appointments for certain professional services and operational decisions for 2022; and,

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., provides that a governing body may award a contract without public advertising for competitive bidding where the nature of said contract is in the form of a professional service; and,

WHEREAS, the subject resolution providing for the awarding of contracts relative to professional services, and the notice of award of said contract shall be made available for public inspection; and,

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i), provides that a notice of the award of said contract be published in a newspaper, said advertisement stating the nature, duration, and amount of the contract; and

WHEREAS, Public Law 1975, Chapter 231, Section 13, requires a public body to post and maintain posted, to distribute to designated newspapers, and to further file with the Municipal Clerk for the purpose of public inspections, a schedule of the regular meetings of such public body to be held during the calendar year; and,

WHEREAS, such schedule of regular meetings is required to contain the location of each meeting, to the extent that it is known, and the time and date of each meeting; and,

WHEREAS, Public Law 1975, Chapter 231, Section 3-D, provides that where the annual notice or revisions thereof, in compliance with sections of the subject act, set forth the location, time and date of any meeting, no further action shall be required for such meeting.

NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District #3 in the Township of Upper, County of Cape May, as follows:

(1) Jon Batastini, Esq., of Garrett & Batastini, P.A., is hereby appointed to provide legal services to the Commissioners for 2022 at an hourly rate of \$175.00.

(2) Cheryl Ward, CPA is hereby appointed to provide accounting services to the Commissioners for 2022.

(3) Ocean City Sentinel Ledger (primary) and The Press of Atlantic City (secondary) are the approved circulation newspapers for public notices.

(4) The 1<sup>st</sup> Bank of Sea Isle City (secondary) are the approved banking facilities.

(5) A schedule of the meetings held in 2022 is attached below.

(6) This resolution and the notice of award of contract shall be available for public inspection.



(8) Michael J. Bohrer, Esq., CPA is hereby appointed the auditor.


