**RE: AN ORDINANCE REVISING JOB CLASSIFICATIONS
AND TITLES AND AMENDING CHAPTER V, ENTITLED
“PERSONNEL”, OF THE CODE OF UPPER TOWNSHIP**

WHEREAS, it is necessary to amend certain job classifications or job titles; and
NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the
Township of Upper, in the County of Cape May and State of New Jersey, as follows:

SECTION 1: Chapter V, entitled “Personnel”, of the Code of Upper Township,
Section 5-6.2, is hereby amended and supplemented as follows:

Add the Following Position:

Laborer, Part-Time

Section 5-6.4, is hereby amended and supplemented as follows:

Add The Following Position:

Laborer, Seasonal

SECTION 2: REPEALER: All Ordinances or parts of Ordinances inconsistent
herewith are hereby repealed to the extent of such inconsistency only.

SECTION 3: SEVERABILITY: This Ordinance shall be subject to the
severability provisions set forth in Section 5-15 of Chapter V of the Code of Upper
Township.

SECTION 4: EFFECTIVE DATE: This Ordinance shall take effect
immediately upon final adoption and publication as required by law.
