#### APPROVAL OF MINUTES - July 11, 2022 Regular and Closed Session Minutes

Motion by Jay Newman, second by Kimberly Hayes, to approve the July 11, 2022, Regular and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

#### **REPORT OF GOVERNING BODY MEMBERS**

**Kimberly Hayes, Committeewoman,** reported on recent complaints regarding the porta-pots in Strathmere. She stated that the facilities will continue to be cleaned on Friday, Saturday, Sunday, Monday, and Wednesday, and will be closely monitored. She next reported on a meeting she and Deputy Mayor Newman had with Triad, the grant writing consultant, and stated that it was an excellent discussion regarding a number of projects. She next reported that the Fall Fest will be held on Sunday October 9<sup>th</sup> from 10:00 am to 5:00 pm. Details will be forthcoming. She next reported that the disc golf course at Amanda's Field is officially open and is a great success. She thanked Craig Reeves, John Adams and the building and grounds crew for their hard work. She also thanked Chris Scott, Jonathan Houdart, and Stefanie Marx for their participation and assistance with the project. She also reminded and encourage residents to clean up after their dogs at Amanda's Field and stated that pet waste stations with bags are available throughout the facility.

**Mark Pancoast, Committeeman**, reported that Code Enforcement remains busy with calls. He next reported that the beach erosion in Strathmere has not worsened. The beach crossovers at Seacliff and Winthrop will remain closed but Williams Avenue is open. Lastly, he reported that the Township has received a new drain truck for use by the Department of Public Works.

**Jay Newman, Committeeman**, reported that the beaches have been very active with approximately 25,000 visitors from Memorial Day to date. He again reminded everyone to refrain from digging holes on the beach.

**Curtis Corson, Mayor**, reported on a complaint he received regarding the truck traffic on Route 9 in Beesley's Point resulting from the demolition of the BL England Plant. He stated that the Township will be discussing the issues with the owners of the property to come up with a plan. He next reported that he also spoke with the grant writing consultants with regard to grants for infrastructure and is hopeful for future opportunities. He next reported that power was out today in Strathmere for approximately two hours due to a pole fire in Sea Isle City. Lastly, he reported that a Planning Board subcommittee has been formed to review matters referred to them by the Township Committee.

# **ADMINISTRATOR OVERVIEW AND FILING OF REPORTS**

**Gary DeMarzo, Township Administrator,** briefly reported on the activities and progress of various projects in the Township including the new drain truck, piping plovers and clean-up of the north end beaches, grant opportunities, and State Police services in the Township.

**Daniel Reeves, Municipal Attorney**, recommended that item 11 on the agenda, introduction of Ordinance 020-2022, be moved to New Business for discussion.

**Paul Dietrich, Township Engineer**, reported that the two historic grant applications have received positive feedback from the County. He has resubmitted some information they had requested and should hear back on the status soon.

# ORDINANCE NO. 019-2022

## AN ORDINANCE AMENDING REVISED GENERAL ORDINANCE CHAPTER III (POLICE REGULATIONS), CHAPTER VI (ALCOHOLIC BEVERAGE CONTROL), AND CHAPTER XXVI (USE OF TOWNSHIP FACILITIES) OF THE CODE OF UPPER TOWNSHIP

BE IT ORDAINED by the Township Committee in the Township of Upper, County of Cape

May and State of New Jersey as follows:

SECTION 1: Chapter 3, Section 13.2, of the Revised General Ordinances of the Township of

Upper, also known as the Code of Upper Township, shall be amended as follows:

# 3-13 PUBLIC DISPLAY AND CONSUMPTION OF ALCOHOLIC BEVERAGES

#### PROHIBITED.

#### Add the following to Section 3-13.2:

3-13.2 Exceptions.

In addition, nothing contained in this section shall apply to any person or persons attending an event in which the sale and consumption of alcoholic beverages is authorized by resolution of the Township Committee pursuant to Chapter 6, Section 6-7 of this Code.

**SECTION 2:** Chapter 6, Section 6-7 is hereby added to the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township:

#### 6 ALCOHOLIC BEVERAGE CONTROL.

#### Add the following to Chapter 6:

6-7 Temporary Permits.

The Township Committee, by resolution, may permit the sale and consumption of alcoholic beverages on Township lands, including public parks, on a one-day permit basis as provided in N.J.S.A. 33:1-74 or on a catering permit basis as provided by regulation or rule of the New Jersey Division of Alcoholic Beverage Control.

**SECTION 3:** Chapter 26, Section 3.7, of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended as follows:

#### 26-3 **REQUIREMENT FOR USE OF FACILITIES.**

#### Add the following to Section 26-3.7:

26-3.7 Use Restrictions.

The prohibition on the use of alcohol shall not apply to any person or persons attending a special event in which the sale and consumption of alcoholic beverages is authorized by resolution of the Township Committee pursuant to Chapter 6, Section 6-7 of this Code.

SECTION 4. REPEALER: All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

<u>SECTION 5.</u> <u>SEVERABILITY:</u> If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

**SECTION 6. EFFECTIVE DATE:** This Ordinance shall take effect upon final adoption and publication as required by law.

#### NEW BUSINESS

- 12. Draft Ordinance amending Chapter 3, Section 1 (Hawking or Peddling Merchandise) of the code of Upper Township. The Municipal Attorney gave a brief review of the matter in which a vendor has challenged the validity of the Township's Ordinance banning door to door solicitation in the Township. He stated that the ban does go against the first amendment rights of the solicitor and if challenged in court the Township would lose. He reviewed some of the terms of the draft Ordinance which will allow door to door solicitation but will require that a license is first obtained from the Township. There followed a lengthy discussion regarding fees and requirements for the license, the implementation of a "Do Not Knock" registry, and whether Homeowners Associations are allowed to ban door to door solicitation. An Ordinance will be relisted for introduction at a future meeting.
- 13. Dennis Township request to purchase Township owned 2005 Sterling vacuum truck. The Township Administrator reported that discussion with Dennis Township on the terms are still ongoing and requested that the matter be listed as unfinished business on the next meeting.

# **UNFINISHED BUSINESS**

14. Remote public meeting access. The Municipal Attorney reported on guidance received from the Division of Local Government Services. He stated that per the DLGS, meetings that are open and available for the public to physically attend does not preclude an individual Committee member from attending virtually as long as there is a quorum of the governing body physically in attendance. If the meeting is not open to the public to physically attend, then the public must be provided with a way to attend virtually. He cautioned that any violation or appearance of a violation of the Open Public Meetings Act runs the risk of litigation and any action that was taken could be invalidated. It was stated that the Township does have the ability to allow members of the public to attend the open public meetings virtually however it would need an additional staff member to facilitate the process. After a lengthy discussion there was a consensus to continue with the current status quo and revisit the matter if needed.
