APPROVAL OF MINUTES - September 12, 2022 Regular and Closed Session Minutes

Motion by Jay Newman, second by Kimberly Hayes, to approve the September 12, 2022, Regular and Closed Session Minutes as submitted. During roll call vote all four Committee members present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Kimberly Hayes, Committeewoman, reported on the Upper Township Historical Society events including themed train rides at the Tuckahoe Train Station, the Applefest at the Gandy Farm and a drive-in movie night on October 22nd at Amanda's Field. She next reported on the upcoming Fall Fest to be held at Amanda's Field on Sunday October 9th and explained that considering the recent tragedy in Wildwood that the Township will be making a few changes to their safety plan for the event.

Mark Pancoast, Committeeman, offered his condolences to the family of those involved in the tragedy that took place during an unsanctioned car show this past weekend in Wildwood and thanked all the law enforcement and emergency workers that responded to the incident.

Jay Newman, Committeeman, announced that the township will hold a Free Rabies Clinic at Shore Veterinarians Animal Hospital on Saturday October 22 from 1:00 to 3:00 p.m. and last reported that on Thursday September 29th, 2022, at approximately 9:30 a.m. the Cooling Tower at the former BL England

Power Plant will be imploded. He explained that all permits have been obtained and necessary safety precautions will be taken.

Curtis Corson, Mayor, reported that there will news crews and be a YouTube video available for anyone that would like to view the implosion of the BL England cooling tower. In addition, the Beesley's Point Development Group has requested permission to use the Township's reverse 911 system to notify residents of the event. Motion by Curtis Corson, second by Jay Newman, to permit the Beesley's Point Development Group the use the Township's reverse 911 system to notify Township residents of the cooling tower implosion. During roll call vote all four Committee members present voted in the affirmative.

ADMINISTRATOR OVERVIEW AND FILING OF REPORTS

Gary DeMarzo, Township Administrator, reported that he recently had the opportunity to attend the Train Festival event at the Tuckahoe Train Station along with Boy Scout Troop 73 from West Cape May. He stated that the event was very nice and thanked the Historical Society for inviting him and the troop. He next gave a brief update on the Atlantic City Electric Reliability project and recent meetings that he attended including a JIF meeting, a meeting regarding the safety plan for the upcoming Fall Festival and an employee meeting regarding the health benefits. Last he reported that he received a phone call from a Township resident who called to thank Court Administrator Loren Ready for her help and professionalism helping her through a court matter.

Barbara Young, Municipal Clerk, requested approval to register employees for the New Jersey League of Municipalities Conference scheduled for November 15 thru 17, 2022 in Atlantic City. Motion by Jay Newman, second by Mark Pancoast, to approve the request. During roll call vote all four Committee members present voted in the affirmative. She next reminded everyone that because of the holiday on Monday October 10, 2022, the next Township Committee meeting will be held on Tuesday October 11th, 2022.

Daniel Reeves, Municipal Attorney, reported that there is one additional resolution to approve a Capital Budget Amendment for this evening's agenda that will be acted on after Closed Session. He also recommended that when there is a spontaneous motion for an item not listed on the agenda that the mayor should call for any discussion on the item to be taken before the roll call vote is called.

Paul Dietrich, Municipal Engineer, reported on the Township's CRS recertification listed on tonight's agenda and requested that a Resolution be placed on a future agenda urging the NJDOT to prioritize the elevation of evacuation routes that are below the base flood elevation. Last, Mr. Dietrich briefly reported on recent updates to the Township's website.

dependency on prescribed pain medicine and its link to heroin abuse in New Jersey.
