CALL TO ORDER

APPROVAL OF MINUTES - December 19, 2022 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Mark Pancoast, to approve the December 12, 2022, Regular and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Victor Nappen, Committeeman, thanked everyone for attending tonight's meeting. He also stated that the reorganization meeting was wonderful and echoed Mr. DeMarzo's compliments for the outstanding singing talents of Mia Pancoast and thanked the boy scouts for attending the meeting. He next thanked former Committeeman John Coggins for his guidance over the past year; he thanked the late former Committeeman Edward Barr for being a wonderful mentor to him; and thanked Mary Lyons for her friendship and for lending her Bible to him during his swearing in on Friday. Lastly, he reported that the Township will be holding free rabies clinics on January 21st and February 25th from 1:00 to 3:00 pm at Shore Veterinarians.

Curtis Corson, Committeeman, reported that the Clerk's Office is short staffed and requested the Township Administrator to schedule interviews so that the vacant position can be filled.

Kimberly Hayes, Deputy Mayor, also echoed the sentiments on the wonderful reorganization meeting and thanked the Clerk's office for their work in organizing the event. She next reported that the recreation

department is meeting to set the dates for all the major events of the year. She stated that the public's input on the planned events is welcome.

Mark Pancoast, Committeeman, reported that the leaf collection is completed, and Public Works is now gearing up for the winter and getting the plows and salt trucks ready for any potential storms that may come. He next reported on a historic event that took place on Friday at the reorganization meeting, during which Kim Hayes became the first woman ever voted to the Deputy Mayor position. He stated that he is honored to be a part of this monumental step and congratulated Deputy Mayor Hayes for her accomplishments.

Jay Newman, Mayor, also reported that the rumble strips on Stagecoach Road have been removed. He next also complimented Mia Pancoast on her wonderful singing talent, and complimented Mr. DeMarzo for his son's excellent bugle playing.

ADMINISTRATOR OVERVIEW AND FILING OF REPORTS

Gary DeMarzo, Township Administrator, stated that the reorganization meeting was beautiful and the singing by Mia Pancoast was exceptional. He next reported that the County has removed the rumble strips along stagecoach Road. He next requested a motion to adopt the filing of his reports.

Paul Dietrich, Municipal Engineer, gave a brief update on the upcoming paving work on Prescott Avenue in Strathmere, He stated that during a recent subcommittee meeting with the parking committee it was proposed to widen that street in order to gain parking and gain additional road width for emergency vehicles. He stated that from an engineering standpoint it is possible to widen the road, but authorization from the Township Committee and an allocation of approximately \$50,000.00 is needed for the extra work. There was then a brief discussion regarding bonding for the project. There was a motion by Curtis Corson, second Jay Newman, to authorize the extra work to widen Prescott Avenue. During roll call vote all five Committee members voted in the affirmative. The CFO stated that she will have more information with regards to funding for the extra work at the next meeting. Mr. Dietrich then reported that the mining licenses will expire on January 31, 2023. Because this is a major review year, the mining operations were required to go before the Planning Board before their license can be renewed. He stated that despite receiving multiple notices of this requirement, three mining operations have not yet gone before the Planning Board. An extension will be needed for their current licenses, and he has requested all three to submit a letter requesting the extension for the Committee's consideration at the next meeting. Next, Mr. Dietrich reported that he recently attended a meeting with the County Planner and the South Jersey Transportation Planning Organization regarding a proposed bike plan. He stated that the SJTPO has hired a consultant to conduct a study for a bike route from Beesley's Point Park to the Dennis Township terminus of the existing Cape May County bike path. The SJTPO consultant has created a website with information for the tentative route. Mr. Dietrich requested approval to post that information on the Township's website for public input. All four Committee members indicated their approval with sharing the information on the Township's website. Committeeman Corson abstained from this discussion due to a possible conflict. Lastly, Mr. Dietrich reminded the Committee that an Ordinance regulating short term rentals is still needed. He stated that the Ordinance is also needed to allow the Township to formulate a program to satisfy the state's requirement for lead-based paint inspection in rental properties.

WHEREAS, in an effort to promote safety for the Upper Township workforce as well as the residents of this community, employees are encouraged to participate in the Upper Township Safety Program and are recognized quarterly for their safety suggestions, from which one is chosen for the overall yearly winner; and

WHEREAS, Andrew Mangam took it upon himself to walk over to the solar field, locate the wires going into the ground, then lined up to the electrical box mounted on the wall of the school building and walked a straight line determining that the underground wires were about 10 feet from where the equipment operator was digging; and

WHEREAS, the equipment operator carefully dug in the area Andrew pointed out, discovering caution tape indicating several inches below were the solar panel wires; and

WHEREAS, due to Andrew's actions a potentially life-threatening situation was averted, and no employees were hurt, and no equipment was destroyed.

WHEREAS, the governing body of the of the Township of Upper has determined that certain procedures need to be established to accomplish this policy; and

NOW, THEREFORE BE IT RESOLVED to affirm and adopt the Township of Upper's civil rights policy as follows:

Section 1: No official, employee, appointee or volunteer of the Township of Upper by whatever title known, or any entity that is in any way a part of the Township of Upper shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township of Upper's business or using the facilities or property of the Township of Upper.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township of Upper to provide services that otherwise could be performed by the Township of Upper.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Township Committee shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Personnel Officer shall establish written procedures that require all

officials, employees, appointees and volunteers of the Township of Upper as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Personnel Officer shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Municipal Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Township of Upper. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township of Upper's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Township of Upper in order for the public to be made aware of this policy and the Township of Upper's commitment to the implementation and enforcement of this policy.
