#### **ORDINANCE NO. 004-2023**

WHEREAS, the Local Government Cap Law, <u>N.J.S.A.</u> 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the **3.5%** percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Upper in the County of Cape May finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee of the Township of Upper hereby determines that a 1.0 % increase in the budget for said year, amounting to \$124,025.93 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Township Committee of the Township of Upper hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Upper, in the County of Cape May a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the Township of Upper shall, in accordance with this ordinance and <u>N.J.S.A.</u> 40A: 4-45.14, be increased by **3.5%**, amounting to \$434,090.76 and that the CY 2023 municipal budget for the Township of Upper be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

#### 2. Introduction of 2023 Budget.

Township Administrator Gary DeMarzo presented a budget slideshow and stated that the 2023 budget will increase \$550,000 or 2.8 cents. Of that increase, \$250,000 will go towards debt service payments to enable the continuation of capital infrastructure projects, and \$300,000 will go towards health benefits and employee contractual obligations. He stated that for the average house assessed at \$300,000 the increase will equal to approximately \$80 in municipal taxes. He further stated that for every \$1,000 in total taxes collected, the Township receives \$120.00.

Registered Municipal Accountant Leon Costello stated that the 2023 Budget is within the spending and levy caps. The budget can be modified up until the budget adoption scheduled for March 27<sup>th</sup>. He further stated that the Governor will be delivering his budget address tomorrow and there may be some modifications relative to what the Governor says.

Motion by Curtis Corson, second by Mark Pancoast, to introduce the 2023 Budget with the public hearing and final adoption scheduled for March 27, 2023, at 4:30 PM. During roll call vote all five Committee members voted in the affirmative. The introduced budget is available for public inspection on the Upper Township website, a copy is available at the Upper Township Branch of the Cape May County Public Library, and copies are available at the Township Clerk's Office.

19. Public hearing and final adoption of Ordinance No. 001-2023 RE: AN ORDINANCE ADOPTING AN AMENDMENT TO THE REDEVELOPMENT PLAN BEESLEY'S POINT REDEVELOPMENT AREA WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY, STATE OF NEW JERSEY. Special Legal Counsel James Maley and Planner Tiffany Cuviello were in attendance for the public hearing and adoption of Ordinance 001-2023. Mr. Maley offered a brief overview of the Ordinance. Municipal Attorney Monzo requested that the public limit their comments to the substance of this Ordinance, keep their comments to the five-minute limit, and be respectful and orderly. He further stated that this is not an interrogation of the Committee, so the Committee will not be answering questions.

Mayor Newman then opened up the public hearing portion for Township residents first. During the public hearing portion there were the following speakers:

**Nathalie Neiss, Petersburg,** stated that there was no public comment portion during the Planning Board meeting when they reviewed this Ordinance. She also spoke about the total acreage of the BL England site.

**Jeff Battersby, Marmora,** spoke in support of this Ordinance.

Elaine Holsombach, Palermo, spoke about our Country's reliance on fossil fuels and the resulting issues.

Andrew Giordano, Upper Township, spoke in opposition to this Ordinance.

Steve Lotus, Marmora, spoke about the need for a substation.

Steve Fanelli, Upper Township, spoke in support of this Ordinance.

**Joe Alietto, Petersburg,** spoke in support of this Ordinance as long as the substation is far away from existing homes.

Greg Foretti, Seaville, spoke in support of this Ordinance.

**Hobie Young, Greenfield,** inquired if the owners of the property are aware of this redevelopment plan. It was stated that the developer is aware and requested the assistance of the Township for this matter.

Barbara Murphy Leary, Seaville, spoke in support of this Ordinance.

Mayor Newman then opened the public hearing to nonresidents.

**Barbara McCall, Ocean City,** attempted to read a statement regarding the Beesley's Point Development Group. The Township Administrator asked Ms. McCall to limit her comment to only this Ordinance, and stated that a general public comment portion will be held later in the meeting.

Mr. Maley again gave a description of the Ordinance and stated that this public hearing is for this Ordinance, not for the development of the former BL England site.

**Patricia Covington, Pennsauken,** continued the statement from the previous speaker. Ms. Covington was again advised that her comment is not relevant to the Ordinance and was requested to limit her comments to Ordinance 001-2023.

Mayor Newman then called for a five minute recess.

Mayor Newman reconvened the meeting to continue public comment for Ordinance 001-2023.

Roseanne Serwatka, Ocean City, spoke in opposition to the Ordinance.

Heidi Yaeg, Cherry Hill, spoke in support of the Ordinance.

Nancy Hollingsworth, Wildwood Crest, stated that the substation is being built for an offshore wind project.

Luanne Caldwell, Ocean City, spoke against the use of wind energy.

Tom Jones, Brigantine, inquired if the substation will be used by Orsted.

Marie, Seaville, spoke in opposition to the Ordinance.

Elaine Holsombach, Palermo, spoke in favor of wind energy.

Jamie Sty, Cape May Court House, inquired into Orsted's involvement with the substation.

**Donna, Ventnor,** spoke in opposition to the Ordinance.

Mike Dean, Middletown, spoke about the political fallout of supporting ocean wind projects.

**Randy**, **Lumberton**, spoke in support of the Committee and the tough decisions they make.

Rich Baerly, Northfield, spoke in opposition to the Ordinance.

Lisa, Atlantic City, spoke in opposition to wind turbines.

Sunny Vargas, Forked River, spoke in support of wind energy.

**Darin Holland, Long Beach Township**, stated that the Township Committee has the opportunity to protect the ocean.

Mayor Newman then closed the public hearing, and opened the discussion to the Committee for comments.

Committeeman Pancoast stated that if the Committee does not act on this Ordinance, the redevelopment of the site will suffer.

Committeeman Corson stated that it may be wise to table this Ordinance until after the congressional hearings.

Committeeman Nappen stated that when he became a Committeeman he vowed to keep Upper Township's interests first in the decisions he makes. He stated that he agrees with the call to pause acting on this ordinance to get more answers to all of the questions about the future of the area and the long term impact offshore wind will have on the community.

Committeewoman Hayes thanked everyone for coming out tonight. She stated that this is not a new process for the Committee. There have been many conversations with professionals and experts. She stated that she wishes to continue to engage in the process and have a say in the redevelopment of the site in order to protect the interests of the Township and its residents. She further stated that the overwhelming majority of Upper Township residents that spoke tonight spoke in favor of this Ordinance.

There was then a motion by Curtis Corson, seconded by Victor Nappen, to table Ordinance 001-2023 until after the congressional hearings. During roll call vote two Committee members voted in the affirmative. Committeewoman Hayes, Committeeman Pancoast, and Mayor Newman voted no. The motion was defeated.

There was then a motion by Kimberly Hayes, seconded by Mark Pancoast, to adopt Ordinance No. 001-2023. During roll call vote three Committee members voted in the affirmative. Committeeman Corson and Committeeman Nappen voted no. The motion was carried.

**WHEREAS**, in order to facilitate the development, redevelopment, and rehabilitation of the Township of Upper, County of Cape May, State of New Jersey (the "Township"), by way of Resolution No. 30-2021 adopted on January 11, 2021, the Mayor and Committee of the Township of Upper (the "Township Committee") declared Block 479, Lots 76, 76.01, 94.01, 106.02, 107, 107.01, 108, and 108.01 within the Township as a Condemnation Area in Need of Redevelopment (the "Redevelopment Area") pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq.; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:12A-7, a Governing Body may adopt, revise or amend a redevelopment plan for an "area in need of redevelopment"; and

- **WHEREAS**, in order to facilitate the redevelopment and rehabilitation of the Township, on January 25, 2021, the Township adopted by way of Ordinance No. 001-2021, redevelopment plan entitled "Beesley's Point Redevelopment Plan Block 479, Lot 76, 76.01, 94.01, 106.02, 107, 107.01, 108, and 108.01" (the "Redevelopment Plan"), dated January 2021, for the Redevelopment Area; and
- **WHEREAS**, the Redevelopment Plan, as amended by the Plan Amendment provides a broad overview for the planning, development, redevelopment and rehabilitation of the Redevelopment Area for purposes of improving conditions within the Township; and
- WHEREAS, the Township Committee has determined that it is in the best interest of the Township to amend the Redevelopment Plan to provide more detailed zoning requirements for electrical substation uses within the Redevelopment Area, and has prepared an amendment entitled "Redevelopment Plan Amendment Beesley's Point Redevelopment Area," dated January 2023, attached hereto ("Plan Amendment"); and
- **WHEREAS**, pursuant to N.J.S.A. 40A:12A-7, the Township Committee adopted a Resolution referring the Plan Amendment to the Township of Upper Planning Board (the "Planning Board") for review, comment and a finding of consistency with the Township Master Plan following introduction and first reading; and
- WHEREAS, the Planning Board held a public hearing on February 16, 2023, and, finding the Plan Amendment to be consistent with and/or designed to effectuate the Township Master Plan, recommended that the Plan Amendment be adopted, via Resolution No. SP01-2023, which shall be considered the report of the Planning Board to the Township Committee as required by N.J.S.A. 40A:12A-7(e) ("Planning Board Report"); and
- **WHEREAS**, the Plan Amendment meets the requirements of N.J.S.A. 40A:12A-1, et seq., and is consistent with and/or designed to effectuate the Township's Master Plan for the reasons set forth in the Plan Amendment and the Planning Board Report; and
- WHEREAS, the Township Committee has reviewed the recommendation of the Planning Board and the Plan Amendment and has determined that it is in the best interest of the Township to adopt the Plan Amendment, attached hereto, in order to effectuate the redevelopment and rehabilitation of the Redevelopment Area.
- **NOW, THEREFORE, BE IT ORDAINED** by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:
- **SECTION 1.** The above-mentioned recitals are incorporated herein as though fully set forth at length.
- <u>SECTION 2.</u> The Township hereby adopts the amendment entitled "Redevelopment Plan Amendment Beesley's Point Redevelopment Area," dated January 2023, attached hereto, and the findings contained therein.
- **SECTION 3.** The Governing Body of the Township of Upper shall have, be entitled to, and is hereby vested all power and authority granted by the aforementioned statutory provisions to effectuate the Redevelopment Plan and the Plan Amendment.
- **SECTION 4.** The Plan Amendment is an overlay zoning for which no zoning map amendment is necessary.
- <u>SECTION 5.</u> The Township Committee declares and determines that the Redevelopment Plan, as amended by the Plan Amendment, provide realistic opportunities for redevelopment of the Amended

Redevelopment Area, and is otherwise in conformance with <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u> and further declares and determines that Plan Amendment is consistent with and/or is designed to effectuate the Master Plan.

**SECTION 6.** All ordinances or parts of ordinances which are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 7.** In the event any clause section or paragraph of this Ordinance is deemed invalid or unenforceable for any reason, it is the intent of the Township Committee that the balance of this Ordinance remains in full force and effect to the extent it allows the Township to meet the goals of the Ordinance.

**SECTION 8.** This Ordinance shall take effect after final adoption and publication according to law.
