APPROVAL OF MINUTES - May 22, 2023 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Victor Nappen, to approve the May 22, 2023 Regular and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Mark Pancoast, Committeeman, gave a brief report on the increased summer operations of the Department of Public Works. He also reminded the public that if they have any Public Works related issues the first course of action should be to contact the Public Works Supervisor. He cautioned against using social media to air complaints as the sites are not monitored and the situation can get out of hand with false information.

Curtis Corson, Committeeman, reminded everyone to please use caution when visiting Township beaches and urged everyone to swim only on protected beaches. He next reported that there has been more erosion to the beaches due to the full moon. Later in the meeting, Committeeman Corson reported that if the beach erosion at Williams Avenue worsens, a shipping container may be placed at the south entrance to house beach patrol equipment.

Kimberly Hayes, Committeewoman, reported on numerous events she and other Committee members attended over the Memorial Day weekend. She thanked the Upper Township Business

Association for inviting her and Mayor Newman to attend a mixer at the Feathered Nest Gifts and Garden Accents in Seaville. Next, she congratulated the Historical Society for their successful Strawberry Festival. She next congratulated the Stratty Paddle Company located on Taylor Road in Strathmere for their grand opening. She next congratulated Boulevard Liquor for their grand reopening. Next, she thanked Osprey Point for hosting a Memorial Day Ceremony and thanked Boy Scout Troop 79 and the American Legion for their participation. Next, she reported that she attended the ribbon cutting ceremony for the opening of the Simon Davies Military Museum and stated that it is an amazing place and encouraged all to visit. She next thanked the Public Works Department for quickly addressing some vandalism that occurred at the East Golden Oak playground. She also thanked the parents of the individuals involved for working with the Township. Next, she gave a brief report on the Community Center renovations and reported that the Township is continuing to accept applications for vendors for the 4th of July event. She next reported that on Wednesday August 23, 2023 the Township will be partnering with Rothman Orthopedics for an event for parents and coaches regarding sports injuries and prevention. More details will be forthcoming. Lastly, she reported that she attended a roundtable event in Lower Township hosted by the South Jersey Perinatal Cooperative to address the lack of maternity care at Cape Regional Hospital and stated that is was encouraging to see so many community organizations come together to address healthcare disparities for women in Cape May County.

Victor Newman, Committeeman, reported that Shore Animal Control has prepared a coyote prevention guide with tips to deter coyotes from your property and encouraged all to view the guideline on the Township's Facebook page or website. He next reported on a recent walk-through inspection of Beacon Animal Rescue facility and congratulated Beacon for doing a wonderful job. He next reported that he attended his son's opening day baseball game and stated that it was a wonderful atmosphere. Next, he reported that the Municipal Courts also had a successful walk-through inspection and stated that the new sound system in the court room will be installed on Thursday. Lastly, he thanked his colleagues for attending all of the Memorial Day weekend events and stated that he was unable to attend as he and his wife were welcoming the birth of their baby girl.

Jay Newman, Mayor, reported that the Tuckahoe state boat ramp facility is now open. He next reported that the EMS Kids Camp program will be held from June 26th to June 30th for middle school age children. Lastly, he thanked Oakridge Campground for inviting him to speak at their Memorial Day event.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, gave a brief report on several projects including the light project at Caldwell Park, a grant for the replacement of the AC unit at Town Hall, and the electric charging station. He also reported that a public hearing for the liquor license renewal for the Deauville will be held at the June 26th meeting. Mr. DeMarzo then introduced Ralph Cooper for a presentation from the Green Team to Paul Dietrich.

Ralph Cooper, Upper Township Green Team, presented a certificate of appreciation and recognition to Paul Dietrich for his many years of work with the Green Team. Mr. Cooper stated that Paul has been instrumental with the Green Team and the Township obtaining the Sustainable Jersey Certification.

Paul Dietrich, Township Engineer, gave a brief report on the beach erosion, which occurred not from a storm but just a full moon. He stated that the Township will need to continue to monitor the beaches for public safety and cautioned residents to stay away from beach scarps as they are extremely unstable. He next gave a brief update on a couple of Strathmere projects. He stated that there will be another week delay for the grading and paving on Prescott Avenue It is anticipated that the paving will be completed by the end of next week. He next stated that the controls for the pump station have been delayed so the pump station project will be postponed until after Labor Day.

WHEREAS, effective July 22, 2022, the Legislature enacted P.L. 2021, c. 182, "An Act concerning certain lead-based paint hazard, and residential rental property, and establishing lead-based paint hazard programs, supplementing P.L. 2003, c. 311 (C. 52:27D-437.1 et al.) amending various parts of the statutory law, and making an appropriation"; and

WHEREAS, pursuant to N.J.S.A. 52:27D-437.16(b)(1), a municipality that maintains a permanent local agency for the purpose of conducting inspections and enforcing laws, ordinances, and regulations concerning buildings and structures, is required to inspect for lead-based paint hazards in certain specified single-family, two-family, and multiple rental dwellings, at the time periods set forth in the statute; and

WHEREAS, pursuant to N.J.S.A. 52:27D-437.16(b)(2) a municipality that does not maintain such a permanent local agency must hire a lead evaluation contractor, certified to provide lead paint inspection services by DCA, or enter a shared services agreement as permitted by law, for the purpose of conducting the inspections for lead-based paint hazards; and

WHEREAS, Pursuant to Section 9 of P.L. 2021, c. 182, the State of New Jersey has allocated the sum of \$3,900,000 to effectuate the purposes of P.L. 2021, c. 182 (C. 52:27D-437.16). <u>PUBLIC COMMENT – LIMITED TO FIVE (5) MINUTES PER PERSON</u>

Elaine Holsomback, Strathmere and Palermo, commended the Committee for installing the new beach entrance signs in Strathmere. She then spoke about the need and importance to have Mobi Mats installed at all of the beach entrances in Strathmere.

Chelsea Headley, Upper Township, spoke about offshore wind development, in particular a May 24th letter which called for a moratorium on offshore wind activity due to recent marine wildlife deaths, and which was signed by 50 Mayors and submitted to Congress. She also spoke about the recently adopted Cape May County Resolution No. 314-23, opposing Orsted's wind projects.

Christine Lord, Upper Township, requested help to replace her hot water heater through the Township's Affordability Assistance Emergency Repair program. It was explained that unfortunately Triad, the administrators of the Affordability Assistance programs, have determined that Ms. Lord is not eligible for additional assistance through the program. It was suggested that she contact the County or State Social Services office for assistance.

Janine Polasovich, Palermo, requested that the Township pass a Resolution to oppose or at least take a stand on the wind farm project. She also encouraged members of the public to take a stand.

Rob Rush, Steelmantown, spoke about the negative effects the offshore wind project will have on the local fishing industry.

Barbara Leary, Seaville, thanked Paul Dietrich for his many years of service. She next spoke on several issues including the moratorium on offshore wind development and the posting of the Committee meeting minutes.

Janet McMahon, **Upper Township**, spoke about the offshore wind project and the negative effects it will have.

Sylvia Lockwood, Cape May Court House, encouraged the Committee to research the matter and learn about the negative impacts wind turbines will have on the environment. She next inquired if any of the closed session items relate to the offshore wind project and if the Committee will be taking any formal action on any closed session items. It was stated that the contract negotiation – Redevelopment Agreements matter is related to the development of the former BL England property, and no formal action will be taken.

Nathalie Neiss, Block 476, Lot 29, spoke about the wind project and the emotion surrounding the issue.

Janice Connell, Strathmere, thanked Paul Dietrich for all of his contributions to Strathmere and Upper Township. She stated that it has been an honor and pleasure working with him and wished him the best of luck. She also spoke about parking enforcement in Strathmere and the offshore wind project.

Blanch Adams, Steelmantown, Upper Township Business Association, thanked Paul Dietrich for all of his work over the years. She stated that he has been a friend to the business community and will be missed.

Denise Powers, Del Haven, spoke in opposition to the offshore wind project and requested that the Committee pass a Resolution to conduct a study on the revenue of Beesley's Point redevelopment versus offshore wind.
