### **APPROVAL OF MINUTES** - July 10, 2023 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Mark Pancoast, to approve the July 10, 2023 Regular and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

### REPORT OF GOVERNING BODY MEMBERS

Mark Pancoast, Committeeman, gave a brief report on the operations of the Department of Public Works. He next reported on a request to clean up the intersection of Route 50 and Tuckahoe Road and asked DPW to help the state and county with the area. The Township Administrator stated that he will notify the state and county of the project.

**Victor Nappen, Committeeman,** reported that the Committee will be reappointing Judge Birchmeier as Municipal Court Judge tonight, and stated that all parties are happy to have him continue.

**Kimberly Hayes, Committeewoman,** gave a brief update on the Township's sports organizations, signups for the upcoming fall season, and the disc golf league. She next reported that the Township will be partnering with Cape Assist to offer the Strengthening Families Program at the Upper Township Senior Center on Wednesdays in August and September. More information can be found on the Township's website and Facebook page.

Curtis Corson, Committeeman, gave a brief report on the Beach Patrol operations.

**Jay Newman, Mayor,** reported on a recent training session with the Upper Township Beach Patrol, the Ocean City Beach Patrol, the Strathmere Fire Company, and the Ocean City Fire Company to practice water rescue operations, and stated that the training went very well. He next reported that he recently met with Senator Testa and the NJDOT Commissioner. During the meeting he was informed that Route 9 from Seaville to Harbor Road will be paved soon. There was also a discussion regarding Exit 20 and he was pleased to hear that the project is in the pipeline. Lastly, he stated that they discussed the Township's request for an emergency light for the Tuckahoe Fire company on Route 50. He stated that previously the NJDOT had approved the project with a 75/25 cost split. However, midway through the process, the price for the project was increased by 120%. He stated that the matter has been resolved and the Township will be responsible for 25% of the original cost of the project.

### **ADMINISTRATOR OVERVIEW**

**Gary DeMarzo, Township Administrator,** recognized Boy Scout Troop 79. He next gave a brief update on several projects including code enforcement's nuisance abatement procedures, resident feedback on the proposed bike path, lights at Caldwell Park, Community Center floors, and the update to the Committee meeting audio equipment.

**Anthony Monzo, Municipal Attorney,** reported that pursuant to his discussion with the Mayor the Ordinance listed for introduction on tonight's agenda will be removed to allow time for further review.

**Zachary Jordan, Engineer**, gave a brief update on the upcoming beach fill project which is anticipated to begin in the fall.

**Barbara Ludy, Chief Financial Officer**, requested to add a contract negotiation matter with Phoenix Advisors to closed session. She next requested approval for Sarah Steiner to attend a third purchasing class in September. Motion by Curtis Corson, second by Kimberly Hayes, to approve the request. During roll call vote all five Committee members voted in the affirmative.
