APPROVAL OF MINUTES - September 11, 2023 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Mark Pancoast, to approve the September 11, 2023 Regular and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Mark Pancoast, Committeeman, gave a brief report on the activities of the Public Works Department. He next gave a brief report on two code enforcement issues at ShopRite and Pine Hill. Lastly, he reported that the microphones have been replaced in the Committee room.

Kimberly Hayes, Committeewoman, reported that the AC unit at the Senior Center has been fixed and thanked the Department of Public Works for their hard work in resolving the issue. She next reported that the Community Center floors are finished. The floors will need to cure and then the bleachers will be installed. The target date for reopening the center will be mid-October. She next gave a brief update on the replacement of the lights at Caldwell Park. She next reported that the Fall Fest will be held on October 8th at Amanda's Field and encouraged all to attend. Next, she reported that she recently attended the Upper Township Business Association mixer hosted by Rich Asset Management on Roosevelt Boulevard. She next reported that the Township is working with the school district on the Safe Routes for Schools grant program and requested the Engineer to give a brief overview of the grant. Lastly, she reported that the Township will be holding a Health and Wellness Fair on October 19th from 3:00 to 5:00 at the Community Center.

Victor Nappen, Committeeman, reported that the Township will be holding a free rabies clinic on October 21st from 1:00 to 3:00 at Shore Veterinarians. He stated that a rabid racoon was recently found in Estell Manor and reminded everyone to make sure their pets are up to date on their rabies vaccinations. He next honored the teachers in Upper Township for their hard work. Lastly, he reported on an email received from a resident regarding an additional public comment portion on the agenda before the Resolutions are adopted.

Curtis Corson, Committeeman, reported that the beach patrol is finished for the season, and stated that approximately 51,000 patrons visited the beaches this season.

Jay Newman, Mayor, gave a brief report on the storm response this past weekend. He cautioned people to stay off the beaches until after the beach fill project and the beaches have been stabilized. Lastly, he requested that the Public Works Department have a plan in place for storm damage brush cleanup.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, gave a brief report on several Township projects including the new audio system in the Committee room, Safe Routes to School grant, Senior Center HVAC issue, paving bid specifications, ShopRite and Pine Hill code enforcement issues, health benefits meeting with employees, and proposed Shared Services Agreements with Corbin City and Sea Isle City.

Anthony Monzo, Municipal Attorney, reported that he was previously directed to prepare an ordinance prohibiting the storage of unregistered and inoperable vehicles on private property. He stated that there is a provision already in the Township Code, so he will be working with the Municipal Prosecutor to work on the provisions and enforcement of the issue.

Zachary Jordan, Township Engineer, stated that he recently attended the preconstruction meeting with the County for Church Road project, which is slated to begin in October. The Mayor requested that the Committee and Public Safety Departments be notified of any detours and road closures. He next reported that the Township will be hosting a Resiliency Planning Meeting on October 2nd which will be an open house-style informational forum to discuss the challenges faced locally from flooding, storm surges, high tides, and other extreme weather events. More information is available on the Township's website.

Turn pot handles toward the back of the stove. Keep a lid nearby when cooking. If a small

grease fire starts, slide the lid over the pan and turn off the burner.

• Create a "kid and pet free zone" of at least three feet (one meter) around the cooking area and

anywhere else hot food or drink is prepared or carried.

Agreement with the Township of Upper whereby the Township of Upper will provide EMS services to the

City of Corbin City; and

WHEREAS, the Township Committee of the Township of Upper deems that a Shared Services Agreement with the City of Corbin City for the purposes expressed herein is in the mutual interest of all parties and also is in the public interest and will promote the public health, safety and welfare; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. SHARED SERVICES AGREEMENT. Pursuant to the provisions of the Uniform Shared Services Act, N.J.S.A. 40A:65-1, et seq., the Township of Upper is hereby authorized and empowered to enter into a Shared Services Agreement with the City of Corbin City to provide emergency medical services.
- 2. SERVICES TO BE PROVIDED BY CONTRACT. The Shared Services Agreement authorized in paragraph 1 hereof shall cover those services, which are enumerated in said Agreement, a copy of which is attached hereto as Exhibit A.
- 3. AUTHORIZATION TO MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the official seal of the Township of Upper.
- 4. COMPLIANCE WITH STATUTORY REQUIREMENTS. The Shared Services Agreement between the City of Corbin City and the Township of Upper shall meet and satisfy the requirements of N.J.S.A. 40A:65-1, et seq., as may be amended and supplemented.
- 5. SEVERABILITY. If any action, subsection, paragraph, sentence or other part of this Resolution is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.
