APPROVAL OF MINUTES - September 25, 2023 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Curtis Corson, to approve the September 25, 2023 Regular and Closed Session Minutes as submitted. During roll call vote all four Committee members present voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Kimberly Hayes, Committeewoman, reported that the Fall Fest was very successful and thanked the Department of Public Works, Recreation Leader Larry Cole, Upper Township OEM, Division of EMS, New Jersey State Police, Cape May County Sheriff's Office and Boy Scout Troop 79. She next reported that the Historical Preservation Society will be holding the annual Applefest at the Gandy farmstead on October 14th from 10:00 to 3:00, the South Shore Stitchers will be holding a craft show at the Community Center on October 14th from 10:00 to 3:00, and the Ancient Order of Hibernians, a local nonprofit organization that raises money for Upper Township families in need, will be holding their annual Irish Festival on October 14th and 15th in Smithville. Next, she reported that the Township is partnering with Cape Assist to host a free drive-in movie night at Amanda's Field on October 21st. Gates will open at 6:00 pm and the movie, Adams Family, will start at 7:00 pm. Next, she reported that the Upper Township Business Association will be hosting their Community Night on November 16th. Vendor applications are available at <u>www.upperbiz.com</u>. Lastly, she reported that

the Upper Township Health and Wellness Fair will be held on October 19th from 3:00 to 5:00 at the Community Center.

Victor Nappen, Committeeman, reported that the Township will be holding a free rabies clinic on October 21st from 1:00 to 3:00 at Shore Veterinarians. He next reported that the Upper Township Rescue Squad still has mums for sale.

Curtis Corson, Committeeman, reported on the continuing issue with illegal dumping in the Township and requested an update to the Ordinance to increase the fines for illegal dumping. The Municipal Attorney was directed to prepare an Ordinance for introduction at the next meeting.

Jay Newman, Mayor, reported that the annual Fire Prevention Open House will be held at Amanda's Field on October 11th. He next reported that on October 26th the smokestack at the former BL England power station will be imploded. The Beesley's Point Development Group will be holding a "Say Goodbye to the Stack" event on Saturday October 21st at 10:00 am.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, reported that the Township is working closely with the New Jersey State Police to investigate the illegal dumping on Bailey Road. He next gave a brief update on the progress of the short term rental subcommittee. Next, he requested permission to offer the use of the EMS building to the Civil Air Patrol to hold their meetings. Next, he requested the addition of a Resolution to the consent agenda to authorize the mayor to sign the National Flood Insurance Program Community Rating System recertification and annual progress report. Lastly, he reported on the continuing issues with the meeting room audio system.

Joanne Herron, Township Clerk, reported that the last day to register to vote in the General Election is October 17th. Voter Registration forms are available in the Clerk's Office or at <u>www.capemaycountyvotes.com</u>.

Anthony Monzo, Municipal Attorney, reported that there is a state statute for illegal dumping, which would be in addition to whatever fines the Township imposes. He stated that he will speak with the Township Prosecutor and draft an Ordinance for the next meeting. He next reported that he has also been working with the Prosecutor to amend the Property Maintenance Code with regard to inoperable vehicles. An Ordinance amending that section of the code will also be prepared for the next meeting.

Zachary Jordan, Township Engineer, reported that a Flood Insurance Promotion Meeting will be held on October 28th at 9:00 am at the Strathmere Fire House. The meeting is sponsored by the Heist Insurance Agency and will have insurance agents, engineers, and the Township's floodplain manager in attendance to review residents' flood insurance policies to ensure that their home is rated accurately. He next reported that the beach replenishment project should begin in mid-December. He next reported that work on the Safe Routes to School grant is ongoing. The Resolution of support on tonight's agenda is part of the application requirements. Next, he reported that there have been complaints regarding flooding on Putnam Avenue. A change order to the stormwater pump contract may be needed to address those issues.

08250 Tuckahoe; and 08270 Woodbine; and

WHEREAS, two of the Township of Upper's postal ZIP Code boundaries - 08230

Ocean View and 08270 Woodbine - are shared with neighboring municipalities, namely the

Township of Dennis and the Borough of Woodbine; and

WHEREAS, while the problems that have resulted from these shared ZIP Code boundaries are numerous, the most grave is the misdirection of emergency services due to the confusion of visitors and residents in Upper Township believing they are in Ocean View or Woodbine, and further exacerbated by the fact that there are many identical street names in Upper, Dennis, and Woodbine; and

WHEREAS, there have been many documented cases where this confusion has led to a delay in emergency services; and

WHEREAS, the Township of Upper has diligently tried to provide public education and awareness of this issue, however, increased transient and non-resident population in the summer months have made those efforts difficult; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. The Township of Upper hereby requests and urges the United States Postal Service to realign the boundaries of postal ZIP Code 08223 to include all of Upper Township, thereby eliminating the use of the 08230 and 08270 ZIP Codes in Upper Township.

3. The Township of Upper hereby requests and encourages our New Jersey Legislators, the Cape May County Board of Commissioners, the Township of Dennis, and the Borough of Woodbine to support our efforts in this endeavor.
