CALL TO ORDER

SUNSHINE ANNOUNCEMENT

Mayor Newman read the following Open Public meeting notice into the record:

"In compliance with the Open Public Meetings Law, I wish to state that on November 9, 2023, the notice of this meeting of the Upper Township Committee was posted on the official Township Bulletin Board, the Upper Township Website, and mailed to the Cape May County Gazette, the Atlantic City Press, the Ocean City Sentinel-Ledger, the Herald Times and filed with the Township Clerk. Tonight's meeting is being video recorded up until the closed session portion of this meeting and will be available on the Upper Township website. I hereby direct that this announcement be made a part of the minutes of this meeting."

APPROVAL OF MINUTES - October 23, 2023 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Curtis Corson, to approve the October 23, 2023 Regular and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Jay Newman, Mayor, read the following statement into the record:

"As I'm sure you are aware, Orsted terminated their Ocean Wind projects. Since the BL England power plant was ordered to be decommissioned years ago, the Township has had 3 goals:

1) The demolition and environmental remediation of the site. 2) The implementation of a redevelopment plan to develop the property consistent with our master plan to create significant municipal revenue to offset Township real estate taxes. 3) If the federal and state governments were going to require the offshore wind projects and connect to the Township substation, the Township must be adequately compensated to minimize the impacts on our taxpayers and residents. Prior to Orsted's termination of the projects, the Township was in negotiations with them to address any and all impacts to the Township. The Township was adamant, and the negotiations became very adversarial. While the projects were terminated, the Township will remain steadfast in its position." Mayor Newman next reported that the beach replenishment and road paving projects will be starting soon. Last, he congratulated Committeeman Corson on his reelection to Township Committee. Later in the meeting he reported on the recent Flood Insurance promotion meeting held in Strathmere.

Kimberly Hayes, Committeewoman, thanked special legal counsel Daniel Young and James Maley for their help and expertise navigating the issues with the former BL England property. She next thanked the residents of

Osprey Point for hosting the Veterans' Day ceremony, and also thanked Gary DeMarzo for allowing his son to play the bugle during the event. Lastly she reminded everyone that the Tree Lighting Ceremony will be held on November 27, 2023 at 6:30 after the Committee meeting.

Mark Pancoast, Committeeman, also congratulated Committeeman Corson. He next thanked Mayor Newman and Deputy Mayor Hayes for serving on the subcommittee for the Ocean Wind project and making sure the entire Committee had up to date information. He next stated that it is "No Shave November" and the members of the Ocean City Police Department have chosen a local gentleman dealing with non-Hodgkin's lymphoma to support. He next reported that two weeks ago he had the opportunity to sit with the Public Works employees for an informal lunch and stated that it was very nice to talk with them and hear their concerns. Next, he reported that leaf collection has begun and reminded everyone that only leaves without debris will be collected. Next, he stated that the County Engineer has reported that the New Bridge Road project should finally begin next year. Lastly, he reported that there was some confusion during election day with changes to some resident's polling districts.

Victor Nappen, Committeeman, stated that he is also participating in No Shave November to bring awareness to men's health issues. He next spoke about how moving it was to attend the Veterans' Day ceremony at Osprey Point. Next, he stated that this past weekend his daughter was baptized at the St. Maximilian Kolbe Church, and stated that the church's youth group will be holding a s'mores and cocoa event on November 19th. Lastly, he congratulated Committeeman Corson on his election victory.

Curtis Corson, Committeeman, reported that the beach replenishment project will commence with surveying this week, and the dredge operation is projected to start in mid-December. Mayor Newman urged everyone to stay off the beaches during the replenishment project.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, also congratulated Committeeman Corson. He then thanked the Committee for inviting his son to play the bugle at the Veterans' Day ceremony. He next reported on several upcoming projects including beach replenishment, lighting at Caldwell Park, road paving, and the emergency beacon light on Route 50. He next requested a motion to approve John Carter to attend an ICS 300 course at a cost of \$225.00. Motion by Kimberly Hayes, second by Jay Newman, to approve the request. During roll call vote all five Committee members voted in the affirmative. Last, he welcomed new Public Work's employee Wesley Yakopcic.

Anthony Monzo, Municipal Attorney, reported that the subcommittee is close to finalizing a draft of the short term rental Ordinance. Once the prosecutor reviews the draft, it will be presented to the Committee for introduction.

Greg Valesi, Township Engineer, reported that the road paving specifications have been submitted to the CFO and Township Clerk, and are ready for advertisement. He stated that the bid has been constructed to have a base bid and two bid alternates.

The Municipal Attorney reported that this Ordinance requires site plan approval for the removal of a telecommunications facility to ensure that the property is restored to the condition prior to the installation and requires that there is adequate security put in place to ensure the project is completed. The Ordinance has been reviewed and recommended for adoption by the Planning Board. During the public hearing portion there were no speakers. Motion by Kimberly Hayes, second by Victor Nappen to adopt Ordinance No. 015-2023. During roll call vote all five Committee members voted in the affirmative.

ORDINANCE NO. 015-2023

RE: AN ORDINANCE AMENDING CHAPTER 19 (LAND SUBDIVISION, SITE PLAN AND LAND USE ADMINISTRATION) OF THE CODE OF UPPER TOWNSHIP REGARDING TELECOMMUNICATIONS FACILITIES

WHEREAS, the Township Committee of the Township of Upper desires to amend Chapter 19

of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township.

BE IT ORDAINED by the Township Committee, in the Township of Upper, County of Cape

May and State of New Jersey, as follows:

SECTION 1. Section 19-4.2 a. of the Township Code is hereby amended by adding the following

development activity which will require site plan approval:

- 11. The removal of any telecommunications facility in accordance with the following conditions:
 - (a) At such time that a licensed carrier plans to abandon or discontinue operation of a telecommunications facility, such carrier shall notify the Township Clerk by certified United States mail of the proposed date of abandonment or discontinuation of operations. Such notice shall be given no less than 30 days prior to abandonment or discontinuation of operations. In the event that a licensed carrier fails to give such notice, the wireless telecommunications facility shall be considered abandoned upon discontinuation of operations.
 - (i) If tower lighting was required by the FAA, the tower owner shall be responsible for all violations and fines associated with its operation.
 - (b) Upon abandonment or discontinuation of use, at the option of the Township, the carrier shall physically remove the telecommunications facility within 90 days from the date of abandonment or discontinuation of use. "Physically remove" shall include, but not be limited to:

- (i) Removal of antennas, mount, equipment shelters and security barriers for the subject property.
- (ii) Proper disposal of the waste materials from the site in accordance with local, county and state solid waste disposal regulations.
- (iii) Restoring the location of the telecommunications facility to its natural condition, except that any landscaping and grading shall remain in the aftercondition.
- (c) If a carrier fails to remove a telecommunications facility in accordance with this section, the Township shall have the authority to enter the subject property and physically remove the facility. The Planning Board will require the applicant to post a bond at the time of approval to cover costs for the removal of the telecommunications facility in the event the Township must remove the facility, which bond shall be required to be approved by the Planning Board Engineer.
- (d) The following definitions shall apply to this Section:

TELECOMMUNICATIONS FACILITY

A facility designed and used for the purpose of transmitting, receiving and relaying voice and data signals from various wireless communications devices including licensed transmission towers, antennas and ancillary facilities. For purposes of this section, amateur radio transmission facilities and facilities used exclusively for the transmission of television and radio broadcasts are not telecommunications facilities.

TELECOMMUNICATIONS OR TRANSMISSION TOWER

This presumption may be rebutted by evidence that refutes the vehicle's inoperability.

Replace Section 11-1.14 (a) in its entirety with the following:

SECTION 11-1.14 MOTOR VEHICLES, TRAILERS, BOATS, RV'S AND ATV'S.

a. Except as provided for in other regulations, no unregistered or inoperable motor vehicle, trailer, boat, recreational vehicle, heavy equipment or ATV shall be parked, kept or stored on any exterior premises, and no vehicle or similar apparatus or equipment shall at any time be in a state of major disassembly, disrepair, or in the process of being stripped or dismantled. Notwithstanding the foregoing, an owner or occupant shall be permitted to keep up to three unregistered or inoperable motor vehicles, or parts thereof, in the exterior rear yard of a premises provided such motor vehicles are part of an ongoing restoration process, the activity and use complies with Chapters **19** and **20**, the motor vehicles are not located within the setback lines of the property, the motor vehicles are screened from view by neighboring properties and there exists no environmental or other hazard associated with such motor vehicles.
