Current proof of RABIES inoculations must be provided (**expiration date must be valid through November 1st of current year pursuant to N.J.S.C. 8:23A-4.2**).\*\* NO LICENSE WILL BE ISSUED WITHOUT IT. Initial proof of spaying or neutering must be provided to qualify for reduced license fee.

4/1 TO 4/30---\$7.00 LATE FEE + LICENSE FEE  
5/1 TO 5/31---\$8.00 LATE FEE + LICENSE FEE  
6/1 TO 6/30---\$9.00 LATE FEE + LICENSE FEE  
7/1 TO 7/31---\$10.00 LATE FEE, ETC... (Increases by \$1.00 for each month late)
