APPROVAL OF MINUTES - March 11, 2024 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Mark Pancoast, to approve the March 11, 2024 Regular and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Mark Pancoast, Committeeman, reported that the Public Works Department is currently installing no parking signs in Strathmere. He next reported that bulk collection will be held on April 2nd and the first of the year brush collection will be held in April. Brush needs to be out for collection no later than April 8th.

Kimberly Hayes, Committeewoman, thanked all that was involved with the egg hunt. Unfortunately due to the weather it had to be held indoors, but the event was very successful. She thanked employees Larry Cole and Barbara Grund, Cheryl Seidel for the facepainting, the Cape May County Library Upper Township Branch, volunteers from the Upper Township Middle School, and the Seaville and Marmora Fire Company Fire Police for their help with traffic.

Curtis Corson, Committeeman, reported that the Strathmere Fishing and Environmental Club would like to perform a beach planting on the secondary dunes in Strathmere and are looking for recommendations as to where to do the planting. The Township Engineer stated that the project will need DEP approval. After a brief discussion, there was a general consensus to support the project along with a recommendation that the SFEC send the request to the Administrator and Engineer to work with the DEP.

Victor Nappen, Committeeman, stated that the Easter Egg Hunt was a very nice event. He next commended employee Janet McBride for her work as the wellness coordinator for the Township.

Jay Newman, Mayor, spoke about the recent Code Red message Deputy Mayor Hayes sent regarding the cut in State Aid to the schools and the effect it will have on the school's budget. He asked that the residents review the information on the Township's page and take any action to help.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, gave a brief report on several issues and projects including the school budget, grants, road paving project, stormwater pumps, and proposed code amendments with regard to parking.

Anthony Monzo, Municipal Attorney, reported that the efforts to acquire the communications tower behind the Rescue Squad will be finalized tonight with the adoption of Ordinance 005-2024.

Ryan MacNeill, Township Engineer, gave a brief report on several projects including the paving project, Strathmere stormwater pumps, living shoreline, Open Space applications for the Skate Park and Beesley's Point Park Phase 2.

Mr. Costello stated that this is a standard Ordinance that is adopted every year. The Township is not exceeding the budget limits but are establishing a CAP Bank. During the public hearing portion there were no speakers. Motion by Kimberly Hayes, second by Mark Pancoast to adopt Ordinance No. 002-2024. During roll call vote all five Committee members voted in the affirmative.

(N.J.S.A. 40A: 4-45.14)

ORDINANCE NO. 002-2024

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the **3.5%** percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Upper in the County of Cape May finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee of the Township of Upper hereby determines that a 1.0 % increase in the budget for said year, amounting to \$129,318.46 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township Committee of the Township of Upper hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Upper, in the County of Cape May a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Township of Upper shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by **3.5 %**, amounting to \$452,614.61 and that the CY 2024 municipal budget for the Township of Upper be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

3. 2024 Budget - Public Hearing.

Mr. Costello stated that there have been no changes to the budget since it was introduced. The tax rate increase is 1.4 cents. The budget is well under the spending and levy caps.

Committeeman Corson stated that this is a good solid budget and thanked everyone for their efforts in preparing it. Committeewoman Hayes stated that it is a solid budget and the

Department heads worked hard to ensure that it was as lean as it could be. She also stated that the work accomplished the past few years has allowed for this small stable increase. Mayor Newman also thanked the professionals, the Township Administrator, and the department heads for their work in preparing the budget.

Mayor Newman then opened the public hearing. During the public hearing there were no speakers. Mayor Newman then closed the public hearing.

The Clerk read the following resolution into the record:

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7 through 7.5 the Township of Upper has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township of Upper meets the necessary conditions to participate in the program for the 2024 budget year.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, County of Cape May, that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the

Chief Financial Officers' certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amount required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with "CAP" law.)
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate, and correctly stated.
 - b. Items of appropriation are properly set forth.
 - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provision of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Director of the Division of Local Government Services.

6. All Food Vendors shall submit a Temporary Food Vendor Application to the Cape

May County Department of Health and shall follow the "Guidelines for Compliance with Chapter 24,

Subchapter 8 Temporary Retail Food Establishments" as established by the Cape May County

Department of Health.

7. Applicable Food Vendors shall obtain a Temporary Cooking Vendor Permit through

the New Jersey Department of Community Affairs, Division of Fire Safety.

8. The Township of Upper reserves the right to limit the size, amount, and type of

Vendors that will participate during the event.

9. The Township Administrator shall have the authority to establish such additional

rules, terms or conditions relating to the event as may be appropriate due to safety, cost or efficiency

reasons, including any such terms or conditions recommended by the New Jersey State Police, the

Township Department of EMS or the Township's Risk Management Consultant.

Thence #2:

Thence #3: Extending in an Easterly direction along the Southerly line of Valley

ORDINANCE NO. 004-2024

AN ORDINANCE ADDING CHAPTER 10, SECTION 2 (LEAD-BASED PAINT INSPECTION IN RESIDENTIAL DWELLINGS) TO THE CODE OF UPPER TOWNSHIP

WHEREAS, pursuant to P.L. 2021, c. 182, the Township Committee of the Township of Upper desires to adopt an ordinance adding Chapter 10, Section 2, to the Revised General Ordinances of the

Township of Upper, also known as the Code of Upper Township, with respect to the requirements and regulations for inspections of lead-based paint in rented residential dwellings.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

SECTION 1. Chapter 10 of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

Add Section 2: LEAD-BASED PAINT INSPECTION IN RESIDENTIAL DWELLINGS as follows:

§10-2.1 Definitions.

Rental Dwelling Units

Shall mean any residential property, regardless of the number of Units, which is not occupied by the owner.

§10-2.2 Lead-Based Paint Inspection. The owner, landlord and/or agent of every Rental Dwelling Unit shall be required to obtain an inspection of the Rental Dwelling Unit for lead-based paint hazards every three years, or at tenant turnover, whichever is earlier.

§10-2.3 Rental Dwelling Units Required to be Inspected. Inspections for lead-based paint in Rental Dwelling Units shall be governed by the standards set forth in N.J.S.A. 52:27D-437.1 et seq. Any Rental Dwelling Unit in the Township of Upper shall be subject to a Lead-Based Paint Inspection as set forth in this Section, unless said Rental Dwelling Unit meets one of the following conditions:

- (i) has been certified to be free of lead-based paint;
- (ii) was constructed during or after 1978;
- (iii) is in a multiple dwelling that has been registered with the Department of Community Affairs as a multiple dwelling for at least 10 years, either under the current or a previous owner, and has no outstanding lead violations from the most recent cyclical inspection performed on the multiple dwelling building under the "Hotel and Multiple Dwelling Law," P.L. 1967, c.76 (C.55:13A-1 et seq.);
- (iv) is a single-family or two-family seasonal rental dwelling which is rented for less than six months duration each year by tenants that do not have consecutive lease renewals; or
- (v) has a valid lead-safe certification.

§10-2.4 Fee for Inspection. A fee in the amount of \$320.00 shall be paid for each lead-based paint inspection. Said fee shall be dedicated to meeting the costs of implementing and enforcing this subsection and shall not be used any other purpose. Alternatively, a dwelling owner or landlord may directly hire a private lead evaluation contractor who is certified to provide lead paint inspection services by the Department of Community Affairs to satisfy the requirements of this Section, in which case the fee for the processing of each lead-based paint inspection shall be \$20.00.

SECTION 2: REPEALER: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

SECTION 3: EFFECTIVE DATE: This Ordinance shall take effect immediately upon final adoption and publication as required by law.

SECTION 4: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

Shall mean a building or group of buildings consisting of individual sleeping units designed for transient travelers. Hotels and Motels shall require: (i) services to be offered to the general public; (ii) temporary lodging rented to the general public on a daily or weekly basis but not for a period to exceed 30 days and not intended to be occupied or used for any primary residential purpose, either temporary or permanent; (iii) a front desk area with full time, on site staf, maintained to serve guests and the public; (iv) maid service offered no less than weekly and other room amenities, including linens and towel service, in a quality manner; (v) a manager and/or desk staff meeting the requirements of State lodging laws and swimming pool regulations; (vi) a restaurant or café with indoor and outdoor dining and wait service for use by guests and the general public; (vii) a fitness and business center for use by guests; (viii) adequate parking for hotel guests and the public in accordance with parking requirements set forth in the Code of the Township of Upper; (ix) advertisement for motel-like services promoting to the general public; and (x) collection and payment of sales and use tax, tourism tax and tourism fees on revenue generated.

SECTION 2: EFFECTIVE DATE: This ordinance shall take effect immediately upon the following publication as required by law.

SECTION 3: REPEALER: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.
