February 26, 2024

A meeting of the Board of Fire Commissioners of the Township of Upper, District #3 was held on February 26,2024 at 5:15 p.m. at the Marmora Volunteer Fire Company on Old Tuckahoe Road in Marmora, NJ. Commissioners Paul Hoster, Doug Snyder, Kurt Austin, Sean Whelan and Jeff Pierson were present. Also present were Cheryl Sayers, CPA, Accountant and Recording Secretary to the Board; Jon Batastini, Esq. Solicitor; Edwin Kooker, Public; Mark Newman and Russell Barham; Deputy Chiefs of the Marmora Volunteer Fire Company.

The meeting was opened by **Jon Batastini** who read the appropriate notice in accordance with the Open Public Meetings Act of the State of New Jersey.

As its first order of business, the board discussed the results of the election, held on February 17, 2024. **Kurt Austin** and **Sean Whelan** were re-elected as Commissioners with three-year terms. The 2024 budget was passed by the voters of District # 3 with 129 "YES" votes and 12 "NO" votes. Both referendum questions regarding future capital purchases were passed.

Mrs. Sayers presented a financial report, including a list of checks and vendor invoices to be approved, signed, and distributed. The board discussed the actual income and expenses relative to the budget.

The Board recognized that insurance expenses have increased significantly. The Board is going to contact McMahon Insurance Company, who is local to the area, to obtain a new quote in an effort to lower the annual premiums.

Ford Scott, the auditor for Upper Township, as part of a usual audit procedure, requested that the Board certify the date and amount of each payment of special district taxes received by the Commission from Upper Township. The Board reviewed the dates and amounts of payments received and certified the payments.

Edwin Kooker suggested that the fire company and commission work together in preparing a long-term plan for the replacement of apparatus. The commission agreed and will meet with the fire company to develop a plan.

The fire company has formed a committee to research the purchase of fire apparatus including a truck and SCBA equipment. **Commissioner Whelan** will be a member of the committee.

The Board requested that **Cheryl Sayers** verify the number and location of hydrants in the district, and reconcile that to the bills from New Jersey American Water.

Cheryl Sayers reminded the Board that the next meeting is scheduled for April 8, 2024 at 5:15 p.m. There being no further business for the Board, the meeting was adjourned at 5:45 p.m.
