CALL TO ORDER

SUNSHINE ANNOUNCEMENT

Mayor Newman read the following Open Public meeting notice into the record:

Tonight's meeting is being video recorded up until the closed session portion of this meeting and will be available on the Upper Township website. APPROVAL OF MINUTES - August 26, 2024 Regular Meeting and Closed Session Minutes

Motion by Kimberly Hayes, second by Victor Nappen, to approve the August 26, 2024 Regular and Closed Session Minutes as submitted. During roll call vote three Committee members voted in the affirmative. Jay Newman and Mark Pancoast abstained.

REPORT OF GOVERNING BODY MEMBERS

Jay Newman, Mayor, requested a couple of changes to the agenda. He requested that the Resolution authorizing execution of a Fifth Amended Memorandum of Understanding for Block 479, Lots 76, 76.01, and 94.01, and the Resolution referring a proposed rehabilitation area designation for the Township of Upper to the Township of Upper Planning Board, be removed from the consent agenda and added to the Resolutions to be acted on after closed session. He next added Contract negotiation – Beesley's Point Development Group and Contract negotiation – Camden Diocese Affordable Housing to the closed session agenda. He next requested that two Resolutions be added after the consent agenda, a Chapter 159 resolution requesting approval of items of revenue and appropriation into the 2024 budget—New Jersey Department of Community Affairs American Rescue Plan Firefighter 2024 Grant in the total amount of \$69,300.00, and authorizing the qualified purchasing agent to prepare specifications and solicit bids for a self-contained breathing apparatus (SCBA) compressor. He next reported that there have been many complaints regarding the increase to Atlantic City Electric rates. He stated that Congressman Van Drew has requested that the Municipalities adopt a Resolution calling for a public hearing with the Board of Public Utilities. He stated that a draft has been prepared and made a motion to adopt the Resolution. The

motion was seconded by Curtis Corson. During roll call vote all five Committee members voted in the affirmative. The Resolution will be listed in the minutes after the consent agenda. He next reported that he and the Township Administrator attended the Cape May County Mayor's roundtable meeting and stated that one of the topics was the opposition to the State's NJPACT/REAL rules and stated that Gary DeMarzo will give an overview of the issue. Lastly, he gave a report on the grants the Township has received this year, which total \$3,053,000.00, and thanked all of the professionals and staff for their work in attaining these funds.

Kim Hayes, Committeewoman, reported that the Mayors Wellness Committee has also created potential grant opportunities. She next reported on the upcoming Fall Fest event to be held on October 6th at Amanda's Field. She stated that they would like to add a large screen streaming service at a cost of \$1,500 to \$2,500 and made a motion to approve the cost not to exceed \$2,500 using the Recreation Trust Fund. The motion was seconded by Mayor Newman. During roll call vote all five Committee members voted in the affirmative. She next requested a meeting with the CFO, the Administrator, and Recreation Leader to review how the funds received from these events are used.

Victor Nappen, Committeeman, welcomed all the families back to school.

Curtis Corson, Committeeman, reported that September 15th will be the last day for guarded beaches.

Mark Pancoast, Committeeman, reported that the bond purchases listed for approval tonight are for Public Works equipment.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, gave a brief report on the Cape May County Mayor's roundtable meeting and went over the possible impacts Executive Order 100 for the NJPACT/REAL rules will have on Cape May County and the Township. He also stated that it was reported that the County will be revising guidelines for Open Space. Next, he reported that on September 16th Woodbine will be holding a conference to talk about the disproportionate burden hosting the MUA landfill has had on his Municipality. Last, he reported that a meeting has been held with all employees regarding the 17% increase to healthcare benefits and the options for a more affordable program.

Ryan MacNeill, Township Engineer, reported that the Township received a 1 million dollar grant for the NJDPT Local Aid Infrastructure Fund which will be used as an extension of the Safe Routes to School project for the extension of the sidewalks down Rt 9 in the area of the Primary and Elementary Schools. He next gave a brief report on the Reconstruction of Putnam Avenue project which will also be partially funded from a NJDOT grant, and should be ready to go out to bid in January 2025. He next gave a brief update on the State's Route 9 project and upcoming overnight detours for the paving portion of the project. Mayor Newman requested that the DOT give daily updates to the EMS and Fire Companies on the closures.

WHEREAS, the Township Committee intends to engage the services of Atlantic Investigations, LLC as a Professional Services Contract; and

WHEREAS, Atlantic Investigations, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that the contractor has not made any contributions to a political or candidate committee in the Township that would bar the award of this contract and that the contract will prohibit the contractor from making any contributions through the term of the contract; and

WHEREAS, the Chief Financial Officer has certified the availability of funds to permit said Contract to be entered into.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

require a high degree of trust or confidence in the individual providing the

relationship between that individual and the municipality;

(C) The services require peculiar ability or skill and demand a high degree of

specialized knowledge or expertise;

(D) The services are such that their relative work must be judged by subjective

considerations that are not susceptible of valuation by competitive

bidding; and

(E) The individual who will provide these services has demonstrated his

competence and particular expertise in the services required.

4. This contract shall have a term of one (1) year commencing upon full execution.

WHEREAS, Congressman Jeff Van Drew and his congressional office have compiled substantial data from thousands of residents which indicated that their energy bills have in some cases, tripled or more, contributing to the severe economic challenges faced by families in our region; and

WHEREAS, the current affordability crisis is exacerbated by these unexpected and unexplainable rate hikes, which place an additional financial burden on our residents during a financially distressing time; and

WHEREAS, it is the mission of the New Jersey Board of Public Utilities (NJBPU) to protect ratepayers and ensure fair and reasonable utility rates, yet these recent actions appear contrary to that mission; and

- 1. Upper Township requests the NJBPU to conduct a thorough investigation into the recent rate increases, including, but not limited to, examining the potential impact of smart meters and any possible connections between the rate increases and the ongoing offshore wind development in our region.
- 2. Upper Township calls on the NJBPU to hold a public hearing in Cape May County as soon as conveniently possible, in order to provide an opportunity for residents to voice their concerns and seek answers regarding these unexpected and unexplainable rate hikes.
- 3. Upper Township requests an immediate moratorium on all electric utility shut offs issued by AC Electric, and further requests a moratorium on future rate increases, until the NJBPU's investigation is complete, and AC Electric provides satisfactory explanations for these rate hikes.

ORDINANCE NO. 013-2024

RE: AN ORDINANCE AMENDING CHAPTER 8 (ANIMAL CONTROL) OF THE CODE OF UPPER TOWNSHIP

BE IT ORDAINED by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

SECTION 1. Chapter 8 (entitled "Animal Control") of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

Add the following to Chapter 8, Section 6:

8-6 ENFORCEMENT.

8-6.4. Notice of Violation Citation.

Notwithstanding the duties and powers granted to the Certified Animal Control Officer, violations of this Chapter may also be enforced by the issuance of a Notice of Violation citation issued by the New Jersey State Police, Township Code Enforcement Officer, or any other person who actually observes or witnesses a violation.

Revise Chapter 8, Section 17 as follows:

8-7 VIOLATIONS AND PENALTIES.

Violations of this Chapter shall be punishable as follows:

a. First offense, in any twelve-month period, a fine of not less than \$100;

- b. Second offense, in any twelve-month period, a fine of not less than \$150;
- c. Third or subsequent offenses, in any twelve-month period, a fine of not less than \$200.
- **SECTION 2: EFFECTIVE DATE:** This ordinance shall take effect immediately upon the following publication as required by law.
- **SECTION 3: REPEALER:** All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.
- **SECTION 4: SEVERABILITY:** If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

SECTION 5: CODIFICATION: This Ordinance shall be codified in the Upper Township Code at the sections referred to above.

WHEREAS, pursuant to Ordinance #001-2021 on January 25, 2021, the Township Committee adopted a redevelopment plan for the Redevelopment Area (the "Redevelopment Plan"), which sets forth, inter alia, the plans for the rehabilitation and redevelopment of the Township; and

WHEREAS, Beesley's Point Development Group, LLC (the "Conditional Redeveloper") is the owner of property within the Redevelopment Area, known as Block 479, Lots 76.01, and 94.01, and a portion of Block 479, Lot 76 (the "Property"); and

WHEREAS, the Redevelopment Law, specifically <u>N.J.S.A.</u> 40A:12A-8(f), authorizes the Township to arrange or contract with a redeveloper for the planning, construction or undertaking of any project or redevelopment work in an area designated as an area in need of redevelopment; and

WHEREAS, pursuant to Resolution #083-2022, the Township and the Conditional Redeveloper entered into a Memorandum of Understanding dated March 28, 2022, in order to exclusively negotiate with Conditional Redeveloper for a period of one hundred and eighty (180) days in an effort to agree upon a Redevelopment Agreement for the rehabilitation and redevelopment of the Property (the "Original MOU"); and

WHEREAS, pursuant to Resolution #269-2022, the Township and the Conditional Redeveloper entered into an amended Memorandum of Understanding dated September 6, 2022, in order to extend the time for the Township to negotiate solely with Conditional Redeveloper in good faith for the redevelopment of the Property for an additional period of one hundred and eighty (180) days from the expiration of the Original MOU (the "Amended MOU"); and

WHEREAS, pursuant to Resolution #112-2023, the Township and the Conditional Redeveloper entered into an additional amended Memorandum of Understanding dated March 29, 2023, in order to extend the time for the Township to negotiate solely with Conditional Redeveloper in good faith for the redevelopment of the Property for an additional period of one hundred and eighty (180) days from the expiration of the Amended MOU (the "Second Amended MOU"); and

WHEREAS, pursuant to Resolution #281-2023, the Township and the Conditional Redeveloper entered into an additional amended Memorandum of Understanding dated September 11, 2023, in order to extend the time for the Township to negotiate solely with Conditional Redeveloper in good faith for the

redevelopment of the Property for an additional period of one hundred and eighty (180) days from the expiration of the Second Amended MOU (the "Third Amended MOU"); and

WHEREAS, pursuant to Resolution #096-2024, the Township and the Conditional Redeveloper entered into an additional amended Memorandum of Understanding dated March 11, 2024, in order to extend the time for the Township to negotiate solely with Conditional Redeveloper in good faith for the redevelopment of the Property for an additional period of one hundred and eighty (180) days from the expiration of the Third Amended MOU (the "Fourth Amended MOU"); and

WHEREAS, the Township continues to have discussions with the Conditional Redeveloper regarding the rehabilitation and redevelopment of the Property and the Township and Conditional Redeveloper have determined that additional time is necessary for negotiation of a Redevelopment Agreement; and

WHEREAS, the MOU provides that the period of time to negotiate can be extended by the Parties' mutual written agreement; and

WHEREAS, the Township Committee has determined that it is in the best interest of the Township to enter into a Fifth Amended Memorandum of Understanding extending the time for exclusive negotiations under the MOU for an additional one hundred and eighty (180) days from the expiration of the Fourth Amended MOU to March 12, 2025.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Upper, County of Cape May, State of New Jersey as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The time for exclusive negotiation between the Township of Upper and Beesley's Point Development Group, LLC for the redevelopment of the Property is hereby extended for an additional one hundred and eighty (180) days from the expiration of the Fourth Amended MOU.
