#### REGULAR MEETING OF THE TOWNSHIP COMMITTEE – 4:30 P.M.

#### **CALL TO ORDER**

#### SUNSHINE ANNOUNCEMENT

Mayor Newman read the following Open Public meeting notice into the record:

"In compliance with the Open Public Meetings Law, I wish to state that on September 20, 2024, the notice of this meeting of the Upper Township Committee was posted on the official Township Bulletin Board, the Upper Township Website, and emailed to the Atlantic City Press, the Ocean City Sentinel-Ledger, the Herald Times and filed with the Township Clerk. Tonight's meeting is being video recorded up until the closed session portion of this meeting and will be available on the Upper Township website. I hereby direct that this announcement be made a part of the minutes of this meeting."

APPROVAL OF MINUTES - September 9, 2024 Regular Meeting and Closed Session Minutes

Motion by Kimberly Hayes, second by Mark Pancoast, to approve the September 9, 2024 Regular and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

#### REPORT OF GOVERNING BODY MEMBERS

Jay Newman, Mayor, spoke about the recent tragedy in which a young Upper Township Indians football player, Easton Beisler, was killed in a car accident while on the way to a football game in Vineland. He stated that he has been amazed to hear the stories about Easton and his great character, and his memory will live on through the stories and tributes to his young life. He stated that he has also been amazed by the way in which the residents of this Township came together quickly and appropriately to honor Easton and support the family. Committeewoman Hayes stated that there is no possible way to thank everyone that came out to support this family and the community as a whole, but she thanked the Football Association Board and the coaches, Cape Assist, the Upper Township School Board and Superintendent, and members of the Department of Public Works that gave their own time to help with traffic control during a recent vigil. She also stated that the other fatality in the accident was a coach for the Vineland football team. He left behind four small children, so there are fundraisers accepting donations for his family. Committeeman Nappen gave his heartfelt condolences to the Beisler family and thanked all that helped, donated, and offered support to the family. Committeeman Pancoast stated that the response to

this tragedy is a testament to the citizens of Upper Township. Committeeman Corson agreed with Committeeman Pancoast and expressed his condolences to the family.

Mayor Newman then reported on a recent incident of a threat to the school and stated that within seconds the schools went into lockdown, and once the threat was cleared by the State Police, they lowered the threat level to shelter in place out of an abundance of caution. Mayor Newman stated that the procedures that were implemented that day are in place for the safety of the children and staff of the school. He stated that the Township was kept informed and updated throughout the day and fortunately an arrest was made within 5 hours. Station Commander MacNeill was in attendance and thanked all for their patience with the rate in which information was given out. Mayor Newman then reported that the Cape May County Health Department has notified the Township regarding several wells in the Township that have mercury contamination. He stated that the County has notified all of the residents with contaminated wells and will continue with testing the surrounding areas. He next requested to add a Resolution to the consent agenda entitled "Resolution designating Block 566, Lot 1 in the Township of Upper as an area in need of rehabilitation." Lastly, he reported that the BPU has responded to the Township's Resolution calling for a public hearing on the recent AC Electric rates. Not much information was given in the response.

**Kimberly Hayes, Committeewoman**, reported that the Historical Preservation Society will be holding their annual Apple Fest on Saturday October 5<sup>th</sup>. The next day, October 6<sup>th</sup>, the Township will be holding the annual Fall Fest at Amanda's Field from 11:00 am to 5:00 pm. Last, she reported that the Township will be holding a Health and Wellness Fair on October 34<sup>th</sup> from 3:00 pm to 5:00 pm at the Community Center.

**Victor Nappen, Committeeman**, reported that the Township will be holding a free rabies clinic on October 26<sup>th</sup> from 1:00 to 3:00 at Shore Veterinarians.

**Mark Pancoast, Committeeman**, reported that #17 on the agenda is for the purchase of some needed equipment upgrades for the Department of Public Works, and #19 on the agenda is a new employee for the Department of Public Works. Lastly, he reported that there will be a free paper shredding event on November 2<sup>nd</sup> from 9:00 am to noon at Reich Asset Management on Roosevelt Boulevard.

**Curtis Corson, Committeeman**, reported that September 15<sup>th</sup> was the last day of guarded beaches and stated that it was a relatively quiet and uneventful summer. He then thanked the Department of Public Works for their help with the clean-up and storage of the beach patrol equipment.

#### **ADMINISTRATOR OVERVIEW**

Gary DeMarzo, Township Administrator, reported that the Township is continuing to work with the employee base regarding the increased costs for employee health benefits. He stated that the employees have been very cooperative as we head toward the open enrollment period on October 1<sup>st</sup>. He next stated that the incident command and chain of command in the Township is amazing as shown during recent events and thanked the NJSP for facilitating that. He next spoke about the mercury contamination in some of the wells in the Township. He stated that there is a spill fund in the state and POET water filtration systems have been given out to the affected residents as an initial first step.

**Joanne Herron, Township Clerk**, reported that October 15<sup>th</sup> is the last day to register to vote in the General Election. Registration forms can be found on the Township's website, the Clerk's office, or at www.capemaycountyvotes.com.

Anthony Monzo, Municipal Attorney, reported that he and the Township Administrator recently met with Colliers Engineering regarding the structural analysis of the cell tower on 2028 Tuckahoe Road. He stated that the configuration of the three carriers will be changed on the tower based upon the bidding which could cause some structural stress on the tower. He stated that Colliers has come up with a solution to relieve the stress by having all of the cable wire run internally. Verizon has already agreed to do so and

as long as the other carriers agree, the matter can be accomplished without any structural modifications to the tower.

Ryan MacNeill, Township Engineer, reported that the Township will be able to use a co-op contract for the Athletic Court Resurfacing project. He next reported that the Reconstruction of Putnam Ave project should be ready to go out to bid by December. He next reported that he is working on the National Flood Insurance Program Community Rating System recertification which will be submitted in the next couple of weeks. Next, he gave a brief update on the Route 9 paving project. Lastly, Committeeman Pancoast asked the Engineer to obtain an update from the County on New Bridge Road.

WHEREAS, there has been so far 25 suspected overdose deaths in Cape May County in this current year 2024 according to the NJ Office of the Attorney General and the majority of the County's treatment admissions were for heroin/other opiates in 2024 according to the NJ Department of Human Services Division of Mental Health and Addiction Services; and

WHEREAS, the Township of Upper supports initiatives designed to raise awareness of the potential for dependency on prescribed pain medicine and its link to heroin abuse in New Jersey.
