APPROVAL OF MINUTES - November 12, 2024 Regular and Closed Session Minutes

Motion by Kimberly Hayes, second by Mark Pancoast, to approve the November 12, 2024 Regular and Closed Session Minutes as submitted. During roll call vote all five Committee members voted in the affirmative.

REPORT OF GOVERNING BODY MEMBERS

Mark Pancoast, Committeeman, reported that the Department of Public Works has received the new dump truck which will help greatly with leaf collection which is currently going on until about mid-December. He reminded the public to make sure the leaves are clear of any sticks or debris.

Victor Nappen, Committeeman, wished everyone a Happy Thanksgiving. He next thanked Public Works for the festive Christmas decorations at Town Hall. Last, he gave a brief report on Municipal Court operations to date. Since January the court has resolved 2,436 tickets, 160 complaints, and 34 DWI related charges for Upper; and 2726 tickets, 150 complaints, and 47 DWI related charges for Dennis. The court recently had their annual court security meeting and was found in full compliance by the State. He thanked the Court Administrator Loren Ready for doing a great job.

Kimberly Hayes, Committeewoman, also wished all a Happy Thanksgiving. She next congratulated the Upper Township Varsity Cheerleaders and the Football teams for their very successful seasons. Last, she reminded everyone to stay for the Christmas tree lighting ceremony tonight after the meeting at 6:30.

Curtis Corson, Committeeman, wished everyone a Happy Thanksgiving. He next stated that budget season is underway. Last, he commended Public Works for decorating Town Hall and the phenomenal job they've been doing with leaf pickup.

Jay Newman, Mayor, reported that before the next Committee meeting on December 9th at 5:30 there will be an awards ceremony for public safety and emergency personnel. He encouraged and welcomed all to attend. He next wished everyone a Happy Thanksgiving and reported that although the State has lifted the fire ban he encouraged all to please use caution.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, gave a brief report on a few agenda items including a new EMT Jeff Taccarino, and Chapter 159 Resolutions for two grants the Township has received. He next reported that the Township provided services for a private company, the Deauville Inn, pursuant to Township Code. After several discussions with the Deauville, there is a requested adjustment to the price of said services. He requested authority to accept the adjusted costs in the amount of \$4,000 from the Deauville Inn for Township services. Motion by Jay Newman, second by Kimberly Hayes, to approve the request. During roll call vote all five Committee members voted in the affirmative.

Anthony Monzo, Municipal Attorney, requested that the contract negotiation – Beesley's Point Development Group matter be removed from closed session.

Barbara Ludy, Chief Financial Officer, requested approval for employee Sarah Steiner to attend a QPA review class at a cost of \$350.00. Motion by Curtis Corson, second by Jay Newman, to approve the request. During roll call vote all five Committee members voted in the affirmative.

Ryan MacNeill, Township Engineer, reported that the Township has been awarded a FY2025 NJDOT Municipal Aid grant for the reconstruction of Klains Lane in the amount of \$142,000.00. Next he reported that the Township will be holding a virtual Flood Insurance meeting on December 18th at 5:30 pm. Notices have been sent to all residents in flood prone areas and the notice is on the website. Lastly, he reported that the DOT Rt 9 paving project is substantially complete. The DOT has requested assistance identifying a punch list of items that should be addressed.

WHEREAS, Cape Assist has completed and submitted a Business Entity Disclosure Certification which certifies that Cape Assist has not made any reportable contributions to a political or candidate committee in the Township that would bar the award of this contract and that the contract will prohibit Cape Assist from making any reportable contributions through the term of the contract; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 2. Cape Assist has registered with the State of New Jersey pursuant to c.57, Laws of 2004 and has provided proof of that registration to the Township of Upper.

WHEREAS, each Fire District is required to maintain an internet presence to provide information relating to the Fire District's business in order to comply with PL 2001, C. 167; and

WHEREAS, Upper Township Fire District No. 1, Upper Township Fire District No. 2, Upper Township Fire District No. 3, and Upper Township Fire District No. 4, have each indicated a desire to enter into a Shared Services Agreement with the Municipality for the routine maintenance of a website page for each Fire District, to be linked from the Township's website, www.uppertownship.com; and

WHEREAS, the Township of Upper has deemed it to be in the best interest of the residents of the Township of Upper to provide such services as a cost saving measure; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee, the governing body of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

1. SHARED SERVICES AGREEMENTS. Pursuant to the provisions of the Uniform Shared Services Act, N.J.S.A. 40A:65-1, et seq., the Township of Upper is hereby authorized and empowered to enter into a Shared Services Agreement with each Upper Township Fire District for the routine maintenance of a website page for each Fire District.

2. SERVICES TO BE PROVIDED; CONTRACT. The Shared Services Agreements authorized in paragraph 1 hereof shall cover those services, which are enumerated in said Agreements, copies of which are attached hereto and made part of this Resolution.

3. AUTHORIZATION TO MUNICIPAL OFFICIALS. The appropriate Township officers and officials are hereby authorized to take any action necessary or advisable to carry out the intent and purpose of this Resolution. Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreements on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreements with the official seal of the Township of Upper.

4. COMPLIANCE WITH STATUTORY REQUIREMENTS. The Shared Services Agreements between each Upper Township Fire District and the Township of Upper shall meet and satisfy the requirements of N.J.S.A. 40A:65-1, et seq., as same may be amended and supplemented.

5. CONTRACT TERM. The term of the Agreements shall extend from January 1, 2025 to December 31, 2029. Either party may cancel the agreement upon 60 days written notice.

6. SEVERABILITY. If any section, subsection, paragraph, sentence or other part of this Resolution is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.

7. REPEALER. All Resolutions or parts of Resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency only.

8. EFFECTIVE DATE. This Resolution shall take effect immediately upon final adoption.

Specifically, the Mayor and Township Clerk are hereby authorized and directed to execute such Shared Services Agreement on behalf of the Township of Upper pursuant to the authority conferred by this Resolution. The Township Clerk is further authorized and directed to seal said Agreement with the seal of the Township of Upper. Additionally, the Mayor is authorized to negotiate modifications in the language of the Agreement prior to his final execution of same so long as said modifications are consistent with the intent and purpose of the authority granted by this Resolution.
- 5. **COMPLIANCE WITH STATUTORY REQUIREMENTS.** The Shared Services Agreement between the Township of Upper and the Township of Dennis shall meet and satisfy the requirements of N.J.S.A. 40A:65-7, as may be amended and supplemented.
- 6. **CONTRACT TERM.** This Resolution authorizes a Shared Services Agreement on a month to month basis for a duration of up to six months beginning on December 1, 2024.
- 7. **SEVERABILITY.** If any action, subsection, paragraph, sentence or other part of this Resolution is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Resolution, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Resolution directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Resolution shall remain in full force and effect.
- 8. **REPEALER.** All Resolutions or parts of Resolutions inconsistent herewith are hereby repealed to the extent of such inconsistency only.
- 9. **EFFECTIVE DATE.** This Resolution shall take effect immediately upon final adoption and publication in the manner provided by law.

21. Public hearing and final adoption of Ordinance No. 014-2024 RE: AN ORDINANCE ADOPTING AN AMENDMENT TO THE REDEVELOPMENT PLAN FOR BEESLEY'S POINT REDEVELOPMENT AREA WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY, STATE OF NEW JERSEY. The Municipal Attorney reported that this Ordinance set the requirement that a redeveloper enter into a Redevelopment Agreement with the Township Committee prior to any Planning Board approval, and set a requirement that a hotel within the WTC district have a minimum height requirement of 60ft. He stated that the developer has requested an amendment to this Ordinance based on information provided by the NJDEP. He stated that Special Legal Counsel James Maley is here tonight to explain the requested amendment. He further recommended that after Mr. Maley's explanation that the Committee consider amending the Ordinance and reschedule the public hearing for the amended Ordinance at the December 9th Committee meeting. Mr. Maley then reported that the developer has requested to amend the Ordinance as follows: "For lots within the WTC District portion of the Beesley's Point Redevelopment Area, motels shall not be permitted. Hotel development shall have a minimum height of 60-feet and a maximum height of 100-feet. Such hotels must include ancillary uses such as conference halls, banquet rooms, and recreational facilities. In addition, after a hotel has been approved by the Planning Board, the following uses shall be permitted along the waterfront at a minimum height of 60-feet and a maximum height of 100-feet: resort commercial structures and/or resort residential structures." Mr. Maley stated that the ordinance with the requested amendments has been reviewed and approved by the Planning Board. There was then a motion by Jay Newman, second by Curtis Corson, to amend Ordinance No. 014-2024 as stated with the public hearing and final adoption scheduled for December 9, 2024. ORDINANCE NO. 014-2024

RE: AN ORDINANCE ADOPTING AN AMENDMENT TO THE REDEVELOPMENT PLAN FOR BEESLEY'S POINT REDEVELOPMENT AREA WITHIN THE TOWNSHIP OF UPPER, COUNTY OF CAPE MAY, STATE OF NEW JERSEY

WHEREAS, in order to facilitate the development, redevelopment, and rehabilitation of the Township of Upper, County of Cape May, State of New Jersey (the "Township"), by way of Resolution

- No. 30-2021 adopted on January 11, 2021, the Mayor and Committee of the Township of Upper (the "Township Committee") declared Block 479, Lots 76, 76.01, 94.01, 106.02, 107, 107.01, 108, and 108.01 within the Township as a Condemnation Area in Need of Redevelopment (the "Redevelopment Area") pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq.; and
- **WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:12A-7, a Governing Body may adopt, revise or amend a redevelopment plan for an "area in need of redevelopment"; and
- **WHEREAS**, in order to facilitate the redevelopment and rehabilitation of the Township, on January 25, 2021, the Township adopted by way of Ordinance No. 001-2021, a redevelopment plan entitled "Beesley's Point Redevelopment Plan Block 479, Lot 76, 76.01, 94.01, 106.02, 107, 107.01, 108, and 108.01" (the "Redevelopment Plan"), dated January 2021, for the Redevelopment Area; and
- **WHEREAS**, on February 27, 2023 the Township adopted, by way of Ordinance No. 001-2023, an amendment to the Redevelopment Plan entitled, "Redevelopment Plan Amendment Beesley's Point Redevelopment Area," dated January 2023; and
- **WHEREAS**, the Redevelopment Plan provides a broad overview for the planning, development, redevelopment and rehabilitation of the Redevelopment Area for purposes of improving conditions within the Township; and
- **WHEREAS**, the Township Committee has determined that it is in the best interest of the Township to amend the Redevelopment Plan; and
- **WHEREAS**, pursuant to N.J.S.A. 40A:12A-7, the Township Committee adopted a Resolution referring the plan amendment to the Township of Upper Planning Board (the "Planning Board") for review, comment and a finding of consistency with the Township Master Plan following introduction and first reading; and
- **WHEREAS**, the Planning Board held a public hearing and, finding the plan amendment to be consistent with and/or designed to effectuate the Township Master Plan, recommended that the plan amendment be adopted, via Resolution No. SP 12-2024, which shall be considered the report of the Planning Board to the Township Council as required by N.J.S.A. 40A:12A-7(e) ("Planning Board Report"); and
- **WHEREAS**, the Township Committee has reviewed the recommendation of the Planning Board and the plan amendment and has determined that it is in the best interest of the Township to adopt the plan amendment in order to effectuate the redevelopment and rehabilitation of the Redevelopment Area.
- **NOW, THEREFORE, BE IT ORDAINED** by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:
- **SECTION 1.** The above-mentioned recitals are incorporated herein as though fully set forth at length.
- **SECTION 2.** The Redevelopment Plan is hereby amended to include the following under "Land Use and Building Requirements:"

Before any application is made to the Planning Board for development approvals for property in the Beesley's Point Redevelopment Area, an Applicant must have entered into a Redevelopment Agreement with the Township. Execution of a Redevelopment Agreement shall be a mandatory checklist item for any application for development as the term is defined in N.J.S.A. 40:55D-3 for any Applicant seeking land use approvals in the Beesley's Point Redevelopment Area and any such application shall not be deemed complete pursuant to N.J.S.A. 40:55D-10.3 until proof of an executed Redevelopment

Agreement has been submitted as part of the application. Only upon execution of a Redevelopment Agreement may an Applicant submit an application for land use approvals before the Planning Board.

For lots within the WTC District portion of the Beesley's Point Redevelopment Area, motels shall not be permitted. Hotel development shall have a minimum height of 60-feet and a maximum height of 100-feet. Such hotels must include ancillary uses such as conference halls, banquet rooms, and recreational facilities. In addition, after a hotel has been approved by the Planning Board, the following uses shall be permitted along the waterfront at a minimum height of 60-feet and a maximum height of 100-feet: resort commercial structures and/or resort residential structures.

SECTION 3. The Governing Body of the Township of Upper shall have, be entitled to, and is hereby vested all power and authority granted by the aforementioned statutory provisions to effectuate the Redevelopment Plan.

SECTION 4. All ordinances or parts of ordinances which are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 5. In the event any clause section or paragraph of this Ordinance is deemed invalid or unenforceable for any reason, it is the intent of the Township Committee that the balance of this Ordinance remains in full force and effect to the extent it allows the Township to meet the goals of the Ordinance.

SECTION 6. This Ordinance shall take effect after final adoption and publication according to law.
