# **REPORT OF GOVERNING BODY MEMBERS**

**Samuel Palombo, Committeeman,** reported that he had a great meeting today with the parks and recreation employees to discuss upcoming projects and events.

**Zachary Palombo, Committeeman,** praised the employees of the Public Works Department for the great job they did with the snow removal during the recent snowstorm, and stated that he heard many compliments from residents.

**Tyler Casaccio, Committeeman,** reported that the Township will be holding free rabies clinics on January 25<sup>th</sup> and February 22<sup>nd</sup> at Shore Veterinarians from 1:00 pm to 3:00 pm. Last, he reported that he is hoping to start negotiations with Dennis Township to address the court situation.

**Victor Nappen, Committeeman,** also praised the Public Works Department for the snow removal. He stated that there were some issues with the County Roads which hopefully will be addressed soon. He next thanked everyone for coming to the reorganization meeting and stated that it is a very exciting time to see everyone moving forward in their new roles.

**Curtis Corson, Mayor,** also praised the Public Works Department and stated that they did a phenomenal job. Next, he acknowledged NJSP Station Commander Lt. MacNeil and asked if he had anything to report. Lt. MacNeill encouraged the new Committee members to reach out to him if they need anything. Last, he reported that the Committee members will be individually meeting with the Township's auditor to go over the budget process.

CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH
MUNICIPAL EMPLOYEES,
OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Township of Upper to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the of the Township of Upper has determined that certain procedures need to be established to accomplish this policy; and

**NOW, THEREFORE BE IT RESOLVED** to affirm and adopt the Township of Upper's civil rights policy as follows:

**Section 1:** No official, employee, appointee or volunteer of the Township of Upper by whatever title known, or any entity that is in any way a part of the Township of Upper shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township of Upper's business or using the facilities or property of the Township of Upper.

- **Section 2:** The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township of Upper to provide services that otherwise could be performed by the Township of Upper.
- **Section 3:** Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.
- Section 4: The Township Committee shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such

procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

**Section 5:** No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

**Section 6:** The Personnel Officer shall establish written procedures that require all officials, employees, appointees and volunteers of the Township of Upper as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

**Section 7:** The Personnel Officer shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

**Section 8:** At least annually, the Personnel Officer shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Township of Upper. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township of Upper's web site.

Section 9: This resolution shall take effect immediately.

**Section 10:** A copy of this resolution shall be published in the official newspaper of the Township of Upper in order for the public to be made aware of this policy and the Township of Upper's commitment to the implementation and enforcement of this policy.

18. Athletic Court Resurfacing project. The Township Engineer reported that the original scope of this project included the resurfacing of the existing basketball and tennis courts at Caldwell Park and the hockey rink at Amanda's Field. Today's meeting discussed the possibility of expanding the scope to construct 12 pickleball courts at Caldwell Park. He reported that he will be finalizing a concept plan for the Committee's review and approval. The Township will be applying for a Local Recreation Improvement grant for additional funding and some of the project will be able to be accomplished by the Department of Public Works.

# PUBLIC COMMENT - LIMITED TO FIVE (5) MINUTES PER PERSON

**Nathalie Neiss, Block 456, Lot 13 and Block 476, Lot 29,** spoke about a subdivision in the early 90s and questioned Mayor Corson on the matter. The Municipal Attorney advised that Committee members not answer questions or allegations unless they can recall all details with specificity. Ms. Neiss then spoke about several additional items including her family history, the Township Engineer, the Township Administrator, property taxes, Town Centers, and a K-12 school in Upper Township. Last, she welcomed the Municipal Attorney.

**Barbara Leary, Seaville,** thanked the Committee for changing the times of the meetings to be more consistent and for encouraging more transparency and public engagement by adding an additional public comment section specific to agenda items.

**Jon Grubb, Tuckahoe,** inquired about a notice he received regarding paving on Route 50 from Corbin City to Upper Bridge Road and asked when the project will be done. The Township Engineer stated that he would get an update on the project from the state. Mr. Grubb next spoke about the traffic and parking issues on Rt 50 near the Community Center, and asked if there can be a temporary solution to keep people from parking near driveways. It was stated that the issue will be addressed to temporarily block cars from parking near driveways.

**Lou Barbito, Petersburg,** stated that the bumps on the Route 50 bridge are bad. It was stated that the bridge is scheduled for replacement. The Township Engineer will get an update on the project from the state.

# RE: AWARDING A CONTRACT FOR PROFESSIONAL SERVICES FOR LABOR ATTORNEY

WHEREAS, there exists a need for the appointment of a Labor Attorney/Counsel for the Township of Upper; and

**WHEREAS**, the services to be performed by the Labor Attorney/Counsel on behalf of the Township of Upper are declared to be professional services performed by individuals authorized by law to practice in such profession, which profession is regulated by law within the meaning of the Local Public Contracts Law (N.J.S.A. 40A:11-1, *et seq.*), and, hence, are exempt from competitive bidding; and

WHEREAS, the Township of Upper has a need to acquire the services of a Municipal Labor Attorney/Counsel through the awarding of a non-fair and open contract pursuant to N.J.S.A. 19:44A-20.5; and

WHEREAS, the Township's Chief Financial Officer has determined and certified in writing that the value of this contract will exceed \$17,500.00; and

WHEREAS, the proposed Municipal Labor Attorney/Counsel will complete and submit a Business Entity Disclosure Certification which certifies that the contractor has not made any reportable

contributions pursuant to N.J.S.A. 19:44A-1, et seq., that, pursuant to P.L. 2004, c.19, would bar the award of this contract, and that the contractor shall not make any such reportable contributions during the term of

this contract; and

WHEREAS, funds are available for the purposes set forth above.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township

of Upper, in the County of Cape May and State of New Jersey, as follows:

1. The allegations of the preamble are incorporated herein by this reference.

2. The Township of Upper hereby appoints and awards a professional services contract to

Blaney, Donohue & Weinberg, P.C., for Municipal Labor Attorney/Counsel services for a term of one (1)

year, commencing as of the date of execution of this Resolution and continuing until such time as their

successor is duly appointed and qualified.

3. Compensation for payment to the Municipal Labor Attorney/Counsel shall be on the

basis of Professional Contracts to be negotiated with such individual and payment for professional services

rendered shall be made by the Township of Upper based upon receipt of submitted invoices from the

contractor that have been reviewed and approved by the Township Committee.

4. The Mayor and the Township Clerk are hereby authorized and directed to execute, on

behalf of the Township of Upper, a professional services contract with the duly appointed Municipal Labor

Attorney/Counsel in accordance with the terms and provisions of the Local Public Contracts Law.

5. Notices of the awarding of this contract shall be published in the Official Newspaper of

the Township of Upper within ten (10) days from the date of adoption of this Resolution.

6. The Business Entity Certification and Determination of Value for the Municipal Labor

Attorney/Counsel contract shall be placed on file with this Resolution.

7. This Resolution shall be effective immediately and is further intended to ratify, confirm

and approve any formal action taken by the Township Committee.
