REPORT OF GOVERNING BODY MEMBERS

Victor Nappen, Committeeman, wished all Eagles fans a happy victory Monday. He next reported that he and Mayor Corson recently attended the Tuckahoe Fire installation dinner, and it was a fun event. He next stated that he and Mayor Corson also attended the EMT dinner this past weekend and learned an interesting statistic that the Township's EMTs responded to over 800 calls last year. He said that statistic is astounding and a testament to all of their hard work. He next reported that the EMS Chief, Mellissa Coker, has submitted her letter of retirement. He requested that the Township present a Resolution to her at the next meeting to honor her for her service.

Samuel Palombo, Committeeman, reported that he has been working with both the Engineer and the Recreation Leader on upcoming projects and events.

Zachary Palombo, Committeeman, thanked the Department of Public Works for all of their hard work. He stated that he recently met with the employees in the department to go over all of their upcoming projects which are many. Last, he reported that he requested that green lights be put up to celebrate the Eagles.

Tyler Casaccio, Committeeman, reported that the Township held a free rabies clinic on January 25th during which 83 dogs and 11 cats were vaccinated, and 30 dog licenses were sold. A second free rabies clinic will be held on Saturday February 22nd from 1:00 to 3:00 at Shore Veterinarians.

Curtis Corson, Mayor, reported that at the recent planning board meeting a resident inquired about the bike path project. He requested that the Township Engineer coordinate with the County Planning Department to attend a Township meeting and give an informational presentation of the proposed plan.

ADMINISTRATOR OVERVIEW

Gary DeMarzo, Township Administrator, made a lengthy statement regarding his employment with the Township and various complaints with the Committee members and a resident of the Township.

Ryan MacNeill, Township Engineer, reported that final plan revisions to the Athletic Court Resurfacing project have been completed and sent to the Committee for review and approval. Once approved, he will obtain updated quotes from the contractors. He next reported that plans for the Reconstruction of Putnam Avenue have also been submitted to the Committee for review. As long as there are no changes, the plans will be submitted to the NJDOT for review.

RESOLUTION OF THE COMMITTEE OF THE TOWNSHIP OF UPPER COMMITTING TO ROUND 4 PRESENT AND PROSPECTIVE NEED AFFORDABLE HOUSING OBLIGATIONS

WHEREAS, the Township has a demonstrated history of voluntary compliance as evidenced by its Round 3 record; and

WHEREAS, pursuant to In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1 (2015) (Mount Laurel IV), on July 2, 2015, the Township of Upper (hereinafter "Upper" or the "Township") filed a Declaratory Judgment Complaint in Superior Court, Law Division seeking, among other things, a judicial declaration that its Housing Element and Fair Share Plan (hereinafter "Fair Share Plan"), to be amended as necessary, satisfies its "fair share" of the regional need for low and moderate income housing pursuant to the "Mount Laurel doctrine;" and

WHEREAS, that culminated in a Court-approved Housing Element and Fair Share Plan and a Final Judgment of Compliance and Repose, which precludes builder's remedy lawsuits until July 1, 2025; and

WHEREAS, on March 20, 2024, Governor Murphy signed into law <u>P.L. 2024</u>, <u>c.2</u> (hereinafter "A4" or "Amended FHA"); and

WHEREAS, A4 calculates the size of the regional affordable housing need as follows "projected household change for a 10-year round in a region shall be estimated by establishing the household change experienced in the region between the most recent federal decennial census, and the second-most recent federal decennial census. This household change, if positive, shall be divided by 2.5 to estimate the number of low- and moderate-income homes needed to address low- and moderate-income household change in the region, and to determine the regional prospective need for a 10-year round of low- and moderate-income housing obligations..."; and

WHEREAS, this means that the regional need equates to 40% of regional household growth; and

WHEREAS, the 1985 version of the Fair Housing Act and A4 both prohibit a result that would compel a municipality to spend its own money on compliance; and

WHEREAS, the theory which permits a municipality to meet its obligations without municipal subsidy is zoning for "inclusionary zoning"; and

WHEREAS, inclusionary zoning most typically requires a 15% or 20% set aside; and

WHEREAS, it is not clear how a regional need predicated upon 40% of anticipated growth can be met with 15-20% set asides and without municipal subsidy; and

WHEREAS, this is exacerbated by the fact that certain other municipalities in the region have an allocation of 0% of the prospective need (new construction obligation), irrespective of the growth in that particular municipality; and

WHEREAS, A4 yields a statewide new construction obligation of over 8,400 affordable units per year; and

WHEREAS, this is a substantially higher annual number than was imposed by COAH in the "Prior Round" or any iteration of its Round 3 regulations; and

- **WHEREAS**, A4 determines the size of the regional need, but does not calculate allocation of the need to individual municipalities; and
- **WHEREAS**, instead, A4 required the Department of Community Affairs ("DCA") to produce non-binding estimates of need on or before October 20, 2024, which it did provide on October 18, 2024 ("DCA Report"); and
- **WHEREAS**, the DCA Report calculates the Township's Round 4 (2025-2035) obligations as follows: a Present Need or Rehabilitation Obligation of 0 units and a Prospective Need or New Construction Obligation of 47 units; and
- WHEREAS, A4 further provides that, irrespective of the DCA's calculation, municipalities are to determine "present and prospective fair share obligation(s)...by binding resolution no later than January 31, 2025"; and
- **WHEREAS**, this resolution satisfies the requirements of A4 by accepting the DCA estimate of need as described in the DCA Report; and
- **WHEREAS**, Section 3 of A4 provides that: "the municipality's determination of its fair share obligation shall have a presumption of validity, if established in accordance with sections 6 and 7" of A4; and
- **WHEREAS**, Township's calculation of need is entitled to a "presumption of validity" because it complies with Sections 6 and 7 of A4; and
- WHEREAS, the Township specifically reserves the right to adjust those numbers based on one or any of the foregoing adjustments: 1) a windshield survey or similar survey which accounts for a higher-resolution estimate of present need; 2) a Vacant Land Adjustment predicated upon a lack of vacant, developable and suitable land; 3) a Durational Adjustment (whether predicated upon lack of sewer or lack of water); and/or 4) an adjustment predicated upon regional planning entity formulas, inputs or considerations, including, but not limited to Cape May County planning documents to include any document from the County which could affect the Township's planning, the Pinelands or Meadowlands regulations and planning documents; and
- WHEREAS, in addition to the foregoing, the Township specifically reserves all rights to revoke or amend this resolution and commitment, as may be necessary, in the event of a successful challenge to A4 in the context of the Montvale case (MER-L-1778-24), any other such action challenging A4, or any legislation adopted and signed into law by the Governor of New Jersey that alters the deadlines and/or requirements of A4; and
- WHEREAS, in addition to the foregoing, the Township reserves the right to take a position that its Round 4 Present or Prospective Need Obligations are lower than described herein in the event that a third party challenges the calculations provided for in this Resolution (a reservation of all litigation rights and positions, without prejudice); and
- WHEREAS, in light of the above, the Mayor and Committee finds that it is in the best interest of Township to declare its obligations in accordance with this binding resolution and in accordance with the Act and
- **WHEREAS**, in addition to the above, the Acting Administrative Director issued Directive #14-24, dated December 13, 2024, and made the directive available later in the week that followed; and
- WHEREAS, pursuant to Directive #14-24, a municipality seeking a certification of compliance with the Act shall file an action in the form of a declaratory judgment complaint "... within 48 hours after

adoption of the municipal resolution of fair share obligations, or by February 3, 2025, whichever is sooner";

WHEREAS, nothing in this Resolution shall be interpreted as an acknowledgment of the legal validity of the AOC Directive and the Township reserves any and all rights and remedies in relation to the AOC Directive; and

WHEREAS, the Township seeks a certification of compliance with the Act and, therefore, directs its Affordable Housing Counsel to file a declaratory relief action within 48 hours of the adoption of this resolution; and

NOW, THEREFORE, BE IT RESOLVED on this <u>27th</u> day of <u>January, 2025</u> by the Committee of the Township of Upper, Cape May County, State of New Jersey, as follows:

- 1. All of the Whereas Clauses are incorporated into the operative clauses of this resolution.
- 2. The Mayor and Committee hereby commit to the DCA Round 4 Present Need Obligation of 0 units and the Round 4 Prospective Need Obligation of 47 units as described in this resolution subject to all reservations of rights, which specifically include:
 - a) The right to adjust the number based on a windshield survey, lack of land, sewer, water, regional planning inputs, or any combination thereof;

The Municipal Attorney stated that this is not a hearing, the Township Committee has been provided with a legal opinion as to the action that can be taken on this matter, and any discussion is up to the Committee. He further stated that there was a public comment section earlier in the meeting which allowed anyone in the public to discuss any item on the agenda. There was then a motion by Samuel Palombo, second by Zachary Palombo to remove Gary DeMarzo from the position of Township Administrator. Before the vote on the motion the Municipal Attorney advised that the Municipal Code of Upper Township as well as state statute creates the position of administrator. There is also state statute that discusses what is required to terminate the role of administrator, and what the requirements are in terms of payouts should the Committee choose to do so. That statute is NJSA 40A:9-138, which states that an Administrator can be removed without cause by 2/3 vote of the Committee. If the Committee chooses to remove Mr. DeMarzo immediately, he will be paid any unpaid balance of his salary as Administrator and his salary as Administrator for the next three (3) calendar months. Conversely the Committee could choose to have him stay on as Administrator for the next three months and the removal will take place on the 91st day. Mayor Corson then called for a roll call vote on the motion to remove Gary DeMarzo from the position of Township Administrator effective immediately. During roll call vote, 4 Committee members voted in the affirmative. Committeeman Casaccio abstained.

WHEREAS, subsequent to the appointment of Gary DeMarzo as Township Administrator, the Governing Body of the Township of Upper resolved through Resolution #290-2023 to enter into an agreement with Gary DeMarzo, which included, in pertinent part, a provision stating, "it has been determined that DeMarzo shall continue to receive his current salary with 70% of such salary allocated to the job duties of fulltime Personnel Officer and 30% of such salary allocated to the duties he performs as the Township Administrator"; and

WHEREAS, pursuant to the Upper Township Municipal Code, as well as state statute, the Township Administrator serves at the pleasure of the Governing Body of the municipality; and

WHEREAS, pursuant to the requirements of N.J.S.A. 40A:9-138, a Township Administrator may be removed without cause by a 2/3 vote of the Governing Body and, in the discretion of the Governing Body, such resolution shall have an immediate effect, provided that the Governing Body resolves to pay the Administrator forthwith any unpaid balance of his salary as Administrator as of the date of his termination, as well as his salary as Administrator for the next three (3) calendar months following adoption of such resolution.

NOW THEREFORE, BE IT RESOLVED, by the Township Committee for the Township of Upper, County of Cape May, State of New Jersey, that:

1. The allegations contained in the preamble of this Resolution are incorporated herein by reference.

- 2. The Township Committee finds that it is in the best interest of the Township of Upper and the operation of Township of Upper government to remove the current Township Administrator. Such removal of the Township Administrator is being made in the exercise of the judgment and discretion invested in the Township Committee pursuant to state statute.
- 3. In accordance with N.J.S.A. 40A:9-138, Gary DeMarzo is hereby removed from his duties as Township Administrator, with payment of his salary as Township Administrator for the time period prescribed in and required by N.J.S.A. 40A:9-138.
- 4. This Resolution shall be effective immediately and is further intended to ratify, confirm, and approve any formal action taken by the Township Committee.
