#### **BUDGET WORKSHOP – 5:00 P.M.**

In preparation of the 2025 Municipal Budget, a budget workshop meeting was called to order this evening at 5:00 PM.

Mayor Corson read the following Open Public meeting notice into the record:

"In compliance with the Open Public Meetings Law, I wish to state that on February 7, 2025 the notice of this Budget Workshop meeting of the Upper Township Committee was posted on the official Township Bulletin Board and the Upper Township Website, emailed to the Atlantic City Press, the Ocean City Sentinel-Ledger, the Herald Times and filed with the Township Clerk. Tonight's meeting is being video recorded and will be available on the Upper Township website. I hereby direct that this announcement be made a part of the minutes of this meeting."

Also present were Municipal Clerk Joanne Herron, Chief Financial Officer Barbara Ludy, Township Engineer Ryan MacNeill, and Township Administrator Joe Verruni.

Mayor Corson stated that it is anticipated that the budget will be introduced at the February 24<sup>th</sup> meeting. All of the Committee members have met with the Township's Registered Municipal Accountant to go over the budget and ask questions. He stated that it is a solid budget, but due to an approximately \$640,000 loss of state aid, there will be a slight increase to the budget. He then asked the other Committee members if they wished to comment.

Committee Casaccio stated that obviously the Governor pulling funding has not helped.

Committeeman Samuel Palombo stated that it is very challenging to overcome a \$640,000 loss, and it is unfortunate that there has to be an increase. He stated that he is satisfied that there has been a complete accounting of everything that is being spent, and this budget represents a balance of cutting spending and making sage decisions for the future.

Committeeman Zachary Palombo stated that the Township will need to work on one small project at a time to bring back the funds lost from state aid.

Mayor Corson then stated that the Committee will have to start thinking outside the box and look for ways to generate revenue and spoke about some possible issues. He then opened up the meeting to public comment, however there were no speakers. There being no speakers there was then a motion by Zachary Palombo, second by Tyler Casaccio, to adjourn the budget workshop meeting. During roll call vote all four Committee members present voted in the affirmative.

There was then a brief recess before the regular meeting began.

#### REPORT OF GOVERNING BODY MEMBERS

**Samuel Palombo, Committeeman,** reported that a difficult decision was made to cancel the Easter Egg Hunt due to manpower and budgetary issues, and stated that discussions are ongoing regarding the 4<sup>th</sup> of July event and finding a fireworks vendor. Mayor Corson stated that a search is also underway to see if someone from the private sector would like to take over the egg hunt. Later in the meeting Committeeman Palombo reported that the Upper Township Rescue Squad will be holding their Valentine's Day rose sale on February 12<sup>th</sup>, 13<sup>th</sup>, and 14<sup>th</sup>.

**Zachary Palombo, Committeeman,** reported on a possible snowstorm in the forecast and stated that Public Works has made the appropriate preparations.

**Tyler Casaccio, Committeeman,** reported that the Township will be holding another free rabies clinic on February 22<sup>nd</sup> from 1:00 to 3:00 at Shore Veterinarians. He next reported that he and Mayor Corson recently had a very good meeting with the Beesley's Point Redevelopment Group.

**Curtis Corson, Mayor,** reported on the budget workshop held earlier and ways the Township is looking to generate income. He stated that he and Committeeman Casaccio also recently met with a solar company looking to use the former landfill on Butter Road. He next welcomed the Township's Temporary Administrator, Joe Verruni.

**Ryan MacNeill, Township Engineer,** reported that the Township has received its annual Community Rating System recertification which will allow the Township to maintain the 25% discount on flood insurance rates for residents. He next gave a brief update on the Athletic Court Resurfacing project and the Reconstruction of Putnam Avenue project.

## PUBLIC COMMENT – LIMITED TO FIVE (5) MINUTES PER PERSON

Nathalie Neiss, Block 456, Lot 13 and Block 476, Lot 28, spoke about several items including the Administrator position, a Cape May County Herald article from February 5, 2025, the name plaque for the Deputy Mayor, the number of people in attendance at the reorganization meeting, and OPRA requests she has recently submitted.

**Andy Kranok, Petersburg**, requested the Township's support in requesting the NJDOT to install a turn lane on Route 50 near the Dollar General. He also requested that the speed limit in that area be reduced. Mayor Corson directed the Engineer and Municipal Attorney to draft a Resolution of support for the reduced speed limit and turn lane for the next meeting.

**Lou Barbito, Petersburg**, inquired about sidewalks on Route 9 and wondered why they are not all along the highway. It was stated that Rt 9 is under the jurisdiction of the NJDOT. Any new commercial project is required to install sidewalks, and the NJDOT has recently replaced and repaired existing sidewalks along Route 9. However, there is no requirement for existing developments to have sidewalks installed.

**Joanne Kettler, Palermo**, spoke about the many potholes on Tuckahoe Road near the middle school and also at the intersection of Butter Road and Stagecoach Road.
