CALL TO ORDER

SUNSHINE ANNOUNCEMENT

Mayor Corson read the following Open Public meeting notice into the record:

Tonight's meeting is being video recorded up until the closed session portion of this meeting and will be available on the Upper Township website. Also present were Municipal Clerk Joanne Herron, Municipal Attorney John Amenhauser, Chief Financial Officer Barbara Ludy, Township Engineer Ryan MacNeill, and Township Administrator Joe Verruni.

APPROVAL OF MINUTES - February 10, 2025 Regular and Closed Session Minutes

Motion by Zachary Palombo, second by Tyler Casaccio, to approve the February 10, 2025 Regular and Closed Session Minutes as submitted. During roll call vote four Committee members voted in the affirmative. Committeeman Nappen abstained.

REPORT OF GOVERNING BODY MEMBERS

Zachary Palombo, Committeeman, stated that despite the predictions on a major storm last week, the Township dodged a bullet with little to no snow. He then reported that Public Works has been performing a lot of inhouse repairs, and he has been very impressed with the Department of Public Works operations.

Tyler Casaccio, Committeeman, reported that the Township held a second free rabies clinic on February 22nd during which 53 dogs and 23 cats were vaccinated and 22 dog licenses were sold.

Samuel Palombo, Committeeman, reported that at the last meeting he had reported that the Township's Easter Egg Hunt was cancelled due to budget cuts. He stated that obviously events like this are very important to the community and so he is very happy to announce that after speaking with local small

business owners and potential sponsors, funding has been obtained and the Easter Egg Hunt will be held on April 6th. He stated that after Easter is planned, they will start working on the 4th of July.

Victor Nappen, Committeeman, congratulated John Amenhauser and his family on the birth of a new baby! He next reported that he is happy to welcome two new full time EMTs Pamala Jones and Timothy Leeds. Lastly, he made a small correction to his report from the January 27th meeting in which he had reported that the Division of EMS had responded to over 800 calls in 2024. In actuality they had responded to over 1,700 calls. Next, he gave a brief report on the Division's upcoming projects and stated that he has been working with them for a possible Easter event. More details will be forthcoming. Lastly, he thanked and praised his fellow committee members for the great job they are doing.

Curtis Corson, Mayor, reported that at the last meeting it was announced that the budget was going to be introduced tonight. However, it was decided to wait to hear the Governor's budget address which is scheduled for tomorrow. It is anticipated that the budget will be introduced at the March 10th meeting.

ADMINISTRATOR OVERVIEW

Joe Verruni, Temporary Township Administrator, gave a brief report on several agenda items including the Community Project Funding grant and authorization to bid for the Tuckahoe Train Station roof replacement. He next reported on the deteriorated condition of the Cedar Square shopping center and stated that he and the Code Enforcement Officer will be meeting next week to go over the issue. Last, he gave a brief update on the recruitment process for candidates for the Township Administrator position.

Ryan MacNeill, Township Engineer, gave an update on several matters including the Athletic Court Resurfacing project, the Strathmere Living Shoreline project, and Butter Road.

<u>PUBLIC COMMENT ON AGENDA ITEMS ONLY – LIMITED TO FIVE (5) MINUTES PER PERSON</u>

Nathalie Neiss, 759 Route 50, inquired about number 2 on the agenda. The Township Engineer reported that this Resolution is in response to a public comment at the last meeting requesting a lower speed limit on Route 50 north of the intersection of Tuckahoe Road and also the installation of a center turn lane. Ms. Neiss requested that the lowered speed limit area be extended south to the intersection of Rt 610. It was stated that the Township was going to move forward with the Resolution as written and the Engineer was directed to look into Ms. Neiss' request. She next inquired about number 16 on the agenda, and if the Township will be using architectural shingles or cedar shakes. It was stated that because the Tuckahoe train Station is a historical building, the roof will be restored with cedar shakes.

Lou Barbito, Frances Drive, complained about the bumps on the Route 50 Cedar Swamp Creek bridge. The Engineer stated that the bridge is scheduled to be replaced in 2026.
