Registered Municipal Accountant Leon Costello was present for the budget introduction portion of the meeting.

#### **APPROVAL OF MINUTES** - February 24, 2025 Regular and Closed Session Minutes

Motion by Victor Nappen, second by Tyler Casaccio, to approve the February 24, 2025 Regular and Closed Session Minutes as submitted. During roll call vote five Committee members voted in the affirmative.

#### REPORT OF GOVERNING BODY MEMBERS

**Samuel Palombo, Committeeman,** reported that the Recreation Advisory Board held their first meeting on February 25, 2025. He stated it was a great productive meeting and gave a brief rundown of the programs that will be starting their seasons soon.

**Victor Nappen, Committeeman,** reported he and Committeeman Tyler Casaccio were invited to speak at the Business Association's dinner on March 6<sup>th</sup>, and a highlight of the meeting was celebrating Action Supply's 40 years of business in the Township. Next, he reported that the Township has received numerous letters of support for a new Public Safety Building from local public safety organizations. Lastly, he stated that the Township has been supportive of the movie shooting locally and he is looking forward to seeing the Township in a film directed by Steven Spielberg.

**Zachary Palombo, Committeeman,** reported that he and others met with NJDEP on Friday March 7<sup>th</sup> to discuss the Strathmere Beach erosion and its effects on public and property safety. He stated that at low tide on Friday the cutouts on the walkways were visible. On Saturday aerial drone footage was taken which showed significant damage to the north end. With summer quickly approaching a game plan on how to deal with the erosion is being worked on.

**Tyler Casaccio, Committeeman,** stated he enjoyed attending the Business Association's annual meeting and speaking with business and community leaders to discuss their concerns and possible improvements.

**Curtis Corson, Mayor,** thanked Committeeman Nappen and Committeeman Casaccio for attending the UTBA dinner. Unfortunately he was not able to attend due to a family emergency. He then stated as a follow up to the beach erosion problem, the northern end of the beach will probably need to be closed for the summer.

#### **ADMINISTRATOR OVERVIEW**

Joe Verruni, Temporary Township Administrator, also spoke about the Strathmere beach erosion and some possible options given by the NJDEP. Next, he thanked Rich Kaczmarski and Brian Keenan for their help with the Cedar Square Shopping Center issue. The owner of Cedar Square has requested a meeting with the Township Committee regarding renovation plans. Next, he gave a brief update on the Living Shoreline project, the MUA Host Community Benefit agreement, grant funding for a new public safety building, and the search for a Township Administer.

**John Amenhauser, Municipal Attorney**, reported that a Rice notice was delivered to Gary DeMarzo for a personnel discussion to be held in closed session. Mr. DeMarzo has requested that the matter be discussed in open session. Mr. Amenhauser requested that Personnel – Gary DeMarzo be added as number 35 under New Business. He also requested that an item be added under closed session entitled Pending litigation – Gary DeMarzo v. Township of Upper et al.

**Ryan MacNeill, Township Engineer**, gave an update on several matters including the Athletic Court Resurfacing project, the Strathmere Living Shoreline project, Route 50 road construction, and the Marshallville Road Bridge replacement.

#### **ORDINANCE NO. 001-2025**

**WHEREAS**, the Local Government Cap Law, <u>N.J.S.A.</u> 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to **2.5%** unless authorized by ordinance to increase it to **3.5%** over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the **3.5%** percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Upper in the County of Cape May finds it advisable and necessary to increase its CY 2025 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee of the Township of Upper hereby determines that a 1.0 % increase in the budget for said year, amounting to \$134,463.73 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Township Committee of the Township of Upper hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Upper, in the County of Cape May a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2025 budget year, the final appropriations of the Township of Upper shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by **3.5%**, amounting to \$470,622.76 and that the CY 2025 municipal budget for the Township of Upper be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Additionally costs for everything have increased. This budget includes a 2.9 cent increase. A public hearing will be held on April 14<sup>th</sup> to answer any questions the public may have. #### **RESOLUTION NO. 81-2025**

A RESOLUTION OPPOSING ATLANTIC CITY ELECTRIC'S 17.23% ELECTRICITY RATE INCREASE, CALLING ON AC ELECTRIC TO WITHDRAW THEIR APPLICATION TO THE NJBPU FOR AN ADDITIONAL 8% INCREASE UP FOR CONSIDERATION IN APRIL, 2025, AND CALLING ON MEMBERS OF THE NJBPU TO RESIGN IMMEDIATELY DUE TO THEIR FAILURE TO UPHOLD THEIR FIDUCIARY DUTY AS BOARD MEMBERS

WHEREAS, many residents throughout the Township of Upper, Cape May County, and the greater South Jersey area continue to experience unexplainable increases in their Atlantic City Electric (ACE) utility bills, exacerbating financial distress amid rising costs of living; and

WHEREAS, on September 9, 2024, the Township Committee of the Township of Upper adopted Resolution 306-2024 calling for a public hearing and investigation into the unexplainable energy bill increases issued by Atlantic City Electric (ACE); and

**WHEREAS**, after Congressman Van Drew's office fielded several constituent complaints and compiled extensive data from thousands of residents indicating ACE energy bill increases as high as 400%, on October 8<sup>th</sup> at a Public Hearing in Mays Landing, Congressman Van Drew called for a federal audit of AC Electric bills; and

**WHEREAS,** the New Jersey Board of Public Utilities (NJBPU's) BGS auction is an opportunity for electric distribution companies in New Jersey to bid to procure electricity supply for customers, essentially setting the price for the standard electric rates through a competitive bidding process; and

**WHEREAS**, despite Congressman Van Drew's efforts to find answers as to why ratepayers across the Township of Upper, Cape May County, and the greater South Jersey area have experienced unexplained increases in their ACE utility bills, this year's BGS audit resulted in ratepayers receiving an additional rate increase of 17.23%, set to go into effect in June of this year; and

WHEREAS, the increased electricity rates will place an undue burden on residents and businesses in the Township of Upper, many of whom are already struggling with inflation, a housing shortage, and other economic challenges like environmental injustice issues promulgated by the State's proposed NJPACT REAL Rules; and

WHEREAS, Atlantic City Electric being a subsidiary of the Exelon Corporation, an IPO with a market cap of over \$43 billion, raises serious concerns about corporate profits being prioritized over the well-being of the residents of the Township of Upper and Cape May County; and

**WHEREAS,** it is the mission of the NJBPU to protect ratepayers and ensure fair and reasonable utility rates, yet these recent actions appear to be contrary to their mission; and

**WHEREAS,** it is the responsibility of government officials at all levels to advocate for fair and reasonable utility rates that do not unduly burden taxpayers and residents.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, that the Township of Upper hereby joins with the County of Cape in requesting the following:

- 1. The Township of Upper hereby opposes ACE's approved 17.23% electricity rate increase, and urges the NJBPU, Governor, and State Legislature to do everything within their power to reverse this decision, in the interest of the residents of the Township of Upper, Cape May County, and the greater Southern New Jersey area that encompasses all 550,000 AC Electric customers.
- 2. The Township of Upper further calls upon ACE to withdraw their application to the NJBPU for an additional 8% increase that is up for consideration in April, 2025.
- 3. **The** Township of Upper hereby calls upon ACE, Pepco Holdings, and Exelon Corporation to publish their internal audit that resulted from Congressman Van Drew's meeting in December.
- 4. The Township of Upper further hereby calls on all members of the NJBPU to resign immediately due to their failure to uphold the fiduciary duty to look out for the best interest of the ratepayers.

**BE IT FURTHER RESOLVED** that a copy of this Resolution shall be submitted to the Offices of Congressman Van Drew, Governor of the State of New Jersey, the New Jersey Board of Public Utilities, the Office of New Jersey's Legislative District 1 – Senator Testa, Assemblyman Simonsen, Assemblyman McClellan, Cape May County Board of County Commissioners, all Municipal Clerks of Cape May County, AC Electric, Pepco Holdings, and Exelon Corporation.

#### **RESOLUTION NO. 82–2025**

### RE: SUPPORTING A REDUCED SPEED LIMIT ALONG ROUTE NJ 49 BETWEEN WOODBINE ROAD AND ROUTE NJ 50

**WHEREAS**, the Township of Upper submitted a request to the New Jersey Department of Transportation (NJDOT) to perform a speed study on Route NJ 49 in Upper Township, in particular from the intersection of CR 617 (Woodbine Road) to the intersection with Route NJ 50; and

WHEREAS, the Bureau of Traffic Engineering has completed an investigation which supports the Township's request and has recommended to establish a 45 MPH Speed Zone on Route NJ 49 in Upper Township between Woodbine Road and Route NJ 50 (approximate mileposts 52.31 and 53.80); and

**WHEREAS**, in order to legally establish the recommended speed zone, the NJDOT is required to promulgate a Traffic Regulation Order and has requested an adopted Resolution of support with the official raised seal of the Township of Upper pursuant to N.J.S.A. 39:4-8.4(c); and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper, in the County of Cape May and State of New Jersey, as follows:

- 1. The allegations of the preamble are incorporated herein by this reference.
- 2. The Township Committee hereby supports the NJDOT's Traffic Regulation Order establishing speed limits along Route NJ 49 in Upper Township as follows:

#### **Eastbound direction of traffic:**

Zone 1: 50 MPH between the Township of Maurice River - Upper Township corporate line and the Upper Township - City of Estell Manor westerly corporate line (approximate mileposts 47.08 to 47.27); thence

#### For both directions of traffic:

Zone 1: 50 MPH between the easternmost City of Estell Manor – Upper Township corporate line and one thousand three hundred (1,300) feet east of Woodbine Road (approximate mileposts 49.84 to 52.60); thence

Zone 2: 40 MPH between one thousand three hundred (1,300) feet east Woodbine Road and Railroad Avenue (approximate mileposts 52.60 to 53.40); thence

Zone 3: 30 MPH between Railroad Avenue and Route NJ 50 (end of route) (approximate mileposts 53.40 to 53.80).

- 3. The Township of Upper concurs that any approved traffic regulations in conflict or inconsistent with the provisions of this Resolution will be rescinded upon approval of the Traffic Regulation Order.
- 4. A certified copy of this Resolution shall be forwarded to the New Jersey Department of Transportation.

#### **RESOLUTION NO. 83-2025**

### RE: AUTHORIZING EXECUTION OF A SIXTH AMENDED MEMORANDUM OF UNDERSTANDING FOR BLOCK 479, LOTS 76, 76.01 AND 94.01

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

WHEREAS, pursuant to Resolution #30-2021 adopted January 11, 2021, the Township Committee of the Township of Upper (the "Township Committee"), designated Block 479, Lots 76, 76.01, 94.01, 106.02, 107, 107.01, 108, and 108.01 within the Township of Upper, Cape May County, State of New Jersey (the "Township) as an "Area in Need of Redevelopment" in accordance with the Redevelopment Law (the "Redevelopment Area"); and

**WHEREAS**, pursuant to Ordinance #001-2021 on January 25, 2021, the Township Committee adopted a redevelopment plan for the Redevelopment Area (the "Redevelopment Plan"), which sets forth, inter alia, the plans for the rehabilitation and redevelopment of the Township; and

**WHEREAS**, Beesley's Point Development Group, LLC (the "Conditional Redeveloper") is the owner of property within the Redevelopment Area, known as Block 479, Lots 76.01, and 94.01, and a portion of Block 479, Lot 76 (the "Property"); and

**WHEREAS**, the Redevelopment Law, specifically <u>N.J.S.A.</u> 40A:12A-8(f), authorizes the Township to arrange or contract with a redeveloper for the planning, construction or undertaking of any project or redevelopment work in an area designated as an area in need of redevelopment; and

WHEREAS, pursuant to Resolution #083-2022, the Township and the Conditional Redeveloper entered into a Memorandum of Understanding dated March 28, 2022, in order to exclusively negotiate with Conditional Redeveloper for a period of one hundred and eighty (180) days in an effort to agree upon a Redevelopment Agreement for the rehabilitation and redevelopment of the Property (the "Original MOU"); and

WHEREAS, pursuant to Resolution #269-2022, the Township and the Conditional Redeveloper entered into an amended Memorandum of Understanding dated September 6, 2022, in order to extend the time for the Township to negotiate solely with Conditional Redeveloper in good faith for the redevelopment of the Property for an additional period of one hundred and eighty (180) days from the expiration of the Original MOU (the "Amended MOU"); and

WHEREAS, pursuant to Resolution #112-2023, the Township and the Conditional Redeveloper entered into an additional amended Memorandum of Understanding dated March 29, 2023, in order to extend the time for the Township to negotiate solely with Conditional Redeveloper in good faith for the redevelopment of the Property for an additional period of one hundred and eighty (180) days from the expiration of the Amended MOU (the "Second Amended MOU"); and
